Sub : Restoration of HAG/IRAS posts.


In terms of Board's sanction No. 2020E(GC)12-87(88) dt. 22.10.2020, HAG/IRAS post of FA&CAO/CON/CR (PC: 02CR3P001) was transferred to SCR for operation as Dir/C-TARA/SCR and SAG/IRAS post of Dir/C-TARA/SCR (PC: 02SC4P005) was transferred to CR for operation in the cadre. Further, in terms of Board's sanction No.2020E(GC)12-33(34) dt. 05.06.2020, SAG/IRAS post of SECR (PC: 02RC4P006) was transferred to SCR. Board have now decided to restore the aforesaid HAG/SAG/IRAS posts to their original locations.

2. Accordingly, sanction of the Ministry of Railways is hereby accorded to the following :-

- (i) Restoration of HAG/IRAS post of FA&CAO/CON/CR (PC: 02CR3P001) from SCR to CR for operation as FA&CAO/CON;
- (ii) Restoration of the SAG/IRAS post of SCR (PC: 02SC4P005) from CR to SCR for operation in the cadre; &
- (iii) Restoration of the SAG/IRAS post of SECR (PC: 02RC4P006) from SCR to SECR for operation in the cadre.

3. Operation of the aforesaid HAG/SAG/IRAS posts will be effective from the date(s) the HAG/SAG posts are released by the concerned Railways or from the actual date of operation of the posts at transferred locations, whichever is later.

4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.






