Sub : Operation of HAG/IRSE posts.

Sanction of Ministry of Railways is hereby accorded to following :-

- (i) post facto transfer of the HAG/IRSE post of PCE/RCF (PC: 03RF3P001) from RCF to WR for its operation as CSO/WR since 25.10.2019;
 - (ii) operation of the HAG/IRSE post of PCSO/WR (PC:03RF3P001) as SDGM/WR; &
 - (iii) transfer of the HAG/IRSE post of SWR (PC:03SW3P004), hitherto being operated as SDGM/SER vide order No. 2020E(GC) 12-29(23) dt. 30.04.2020, to ECoR for operation as CPD/BW/ECoR,
2. RCF is advised to discontinue the operation of SAG/IRSE post of CE(old postcode-1296) which has been upgraded to HAG in the cadre review of IRSE.
 3. Operation of the posts at transferred locations will be effective from the date of the release of the posts by concerned Units or from the date of actual operation of the posts at transferred locations, whichever is later.
 4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.




