

- (i). Restoration of vacant HAG/IRTS post (PC:11ER3P001), presently being operated as SDGM/WR, from WR to ER for its operation as PCOM(PHOD)/ER.
 - (ii). Restoration of SAG/IRTS post (PC:11NC4P006), presently being operated as Chief System Officer/Coaching/NR, from NR to NCR for its operation as PCOM(CHOD)/NCR.
 - (iii). Restoration of HAG/IRTS post (PC: 11RC3P002), presently being operated as CCO/NCR, from NCR to SECR for its operation as PCOM/SECR.
 - (iv). Restoration of HAG/IRTS post (PC:11EC3P002), presently being operated as PCOM/SECR, from SECR to ECR for its operation as PCOM(PHOD).
 - (v). Operation of HAG/IRTS post of PCCM/NCR (PC: 11NC3P002) as CCO/NCR.
 - (vi). Restoration of HAG/IRTS post (PC:11EC3P001), presently being operated as SDGM/NR, from NR to ECR for its operation as PCCM(PHOD)/ECR.
2. Operation of the posts at transferred locations will be effective from the date of release of the posts by the concerned units or from the date of actual operation of the post at the transferred locations, whichever is later.


