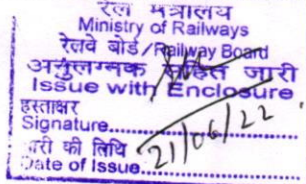
Sub: Transfer/operation/restoration of HAG/SAG IRSSE/IRSE posts.

- (iii) Transfer of HAG/IRSSE post (PC:10RD3P001) of PED/Q&A/S&T/RDSO (Sr.ED/Q&A/S&T/LKO) to SCR for its operation as AGM/SCR;
- (iv) Transfer of SAG/IRSSE post (PC:10RD4P006) of ED/Shreshtha/RDSO to Centre of Excellence at IRISSET;
- (v) Transfer of SAG/IRSSE post (PC:10RD4P012) of ED/Q&A/S&T/LKO to WCR for its operation in the cadre;
