Sub : Transfer/Operation of HAG/SAG/IRTS posts.

Sanction of Ministry of Railways is hereby accorded to the following:-

- (i) Transfer of HAG/IRTS post (PC:11NC3P002) of PCCM/NCR to WR for its operation as CCO/WR.
 - (ii) Operation of SAG/IRTS post (PC:11NR4P010), hitherto being operated as CCO/NR, in the IRTS cadre of NR.
 - (iii) Operation of HAG/IRTS post (PC:11NE3P002), hitherto being utilized as CSO/NR, as CCO/NR.
 - (iv) Temporary operation of SAG/IRTS post (PC:11NW4P005) as PCOM(ChOD)/NWR; &
 - (v) Temporary operation of HAG/IRTS post (PC:11NW3P002) of PCOM/NWR as CCO/NWR.
2. Operation of the posts at transferred locations will be effective from the date of release of the posts by the concerned units or from the date of actual operation of the post at the transferred locations, whichever is later.
 3. Since the HAG/IRTS post (PC:11NC3P002) was upgraded from SAG post of PCCM (Old PC:2798) in the cadre review sanction dated 09.03.2019, NCR is advised to discontinue operation of the SAG/IRTS post of PCCM (Old PC:2798). Further, since the HAG/IRTS post (PC:11NW3P002) was upgraded from SAG post of PCOM (Old PC:3360) in the cadre review sanction dated 09.03.2019, NWR is advised to discontinue operation of the SAG/IRTS post of PCOM (Old PC:3360).
