

Sub: Transfer of HAG/IRSSE post from North Central Railway to Western Railway.

Sanction of the Ministry of Railways is hereby accorded to transfer the HAG/IRSSE post (PC: 10NC3P001) of CSTE/Project/NCR from NCR to WR for its utilization in the cadre over WR for a period of six months i.e. upto 02.05.2023. Thereafter, the said HAG/IRSSE post (PC: 10NC3P001) stands restored to NCR w.e.f. 03.05.2023

2. Operation of the HAG/IRSSE post (PC: 10NC3P001) at WR will be effective from the date of release of the post by NCR or from the date of actual operation of the post at WR, whichever is later.
3. NCR is advised to discontinue operation of SAG post (Old PC: 10605) of CSTE/Proj. which was upgraded to HAG as CSTE/Project-I in Cadre Review, if not done earlier.


