Sub: Transfer of JAG/Sr. Scale/IRSS Posts.

Sanction of the Ministry of Railways is hereby accorded to the following :-

- (i) Transfer of JAG/IRSS post (PC: 09SC5P003) from SCR to MCF for its operation as Dy. CMM/MCF; and
 - (ii) Transfer of 01 Sr. Scale/IRSS work-charged post (PC: 09RE6W002) from CORE to SCR for its operation as SMM/SCR.
2. Operation of the JAG/IRSS post (PC: 09SC5P003) at MCF will be effective from the date of release of the post by SCR or from the date of actual operation of the post at MCF, whichever is later. Operation of the Sr. Scale/IRSS work-charged post (PC: 09RE6W002) at SCR shall be effective only after the proposal for extension of currency of the post is processed in Board's office after due approval by Board (Member/Finance and CRB & CEO).
3. As currency of the SS/IRSS work-charged post (PC: 09RE6W002) is only up to 30.06.2024, SCR is advised to formulate proposal for extension of currency of this work-charged post beyond 30.6.2024 as per latest yardsticks & availability of funds in the sanctioned estimate and send to Railway Board along with functional justification for operation of this post, with the concurrence of Associate Finance and approval of GM.
