Instruction/Guidelines for candidates appearing for medical examination on the basis of Combined Medical Services Examination (CMSE) 2022 (Reserve List)

On the basis of Combined Medical Services Examination 2022 (Reserve List), the candidates (02 in number) shall have to present themselves for medical examination before the Medical Board on 29.07.2024 and 30.07.2024 at 9 A.M on the venue mentioned against their name in the attached letter.

a. Please note that no request for change in scheduled date/place of medical exam shall be entertained. Candidates should report to the Medical Director of the Hospital on the date and time specified against their name in the letter. Please ensure to bring the following:

- i. **3 passport size photographs (with Name, Roll No. on the reverse).**
- ii. **Spectacles prescribed, if any, and the prescription slip indicating the power of glasses.**
- iii. **Any Government issued document with photograph thereon as proof of identity.**

b. Candidates will be required to deposit the prescribed medical examination fees with the said hospital. Please note that candidates could be asked to stay in case a Special Medical Board is arranged to examine them or any other detailed medical examination is required in their case.

c. Please note that in case a candidate fails to report for medical examination on the date and time indicated above he/she will not be given any further chance for medical examination (unless justified reasons viz quarantine policy for inter-state movements for which Nodal Officers at Headquarter level may grant you another date at the same venue) and will not be considered for the post of ADMO in IRHS on the basis of Combined Medical Services Examination 2022 (Reserve List). No TA/DA shall be paid to the candidates in connection with medical examination. Further, this communication does not involve any commitment for offer of appointment.

d. **Please note that no correspondence will be entertained w.r.t. to change in medical examination date or venue.**

e. Please note that no separate written communication will be sent to the candidates regarding medical examination.

g. Candidates are requested to acquaint themselves with Appendix-III of CMSE Rules-2022 before proceeding to medical examination. Persons with Benchmark Disability (PwBD) candidates are advised to carry three sets (physical) of Certificate of Disability alongwith Original for verification at the time of medical examination.
