- 4. As per Zonal Allocation Policy there is no provision for change of allotted zone. However, request for transfer posting on Persons with Benchmark Disability (PwBD) or Spouse Grounds can be considered after the Probationer has joined the working post in his/her allotted Railway and that too if the same is forwarded through proper channel, subject to availability of vacancies and in terms of Transfer Policy contained in Board's letter No. 2020/E(GR)II/7/3 dated 15.10.2020.
