

G.S.R. (E).--- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the President hereby makes the following rules to amend the Indian Railways Prosecution Cadre (Group A and B Gazetted posts) Recruitment Rules, 2022, namely:-

1. (i) These rules may be called the Indian Railways Prosecution Cadre (Group A and B Gazetted posts) (Amendment) Rules, 2024.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Indian Railways Prosecution Cadre (Group A and B Gazetted posts) Recruitment Rules, 2022, in the Schedule, for the post of Assistant Legal Officer (Prosecution), in column 11, under the heading 'By Promotion', the words

“Senior Public Prosecutor in level 8 (Rs. 47600-151100) of the pay matrix with six years regular service in level 8”

shall be substituted by the words

“Senior Public Prosecutor in level 8 (Rs. 47600-151100) of the pay matrix with eight years regular service in level 8”

3. For the post of Assistant Legal Officer (Prosecution), in column 11, the existing Note shall be renumbered as Note 1 thereof and after Note 1 as so renumbered, the following Note shall be inserted:

“Note 2: The eligibility service of ‘six years’ for promotion of incumbents holding feeder cadre posts on regular basis, shall continue to be the same on the date of notification of the amendment.”

“Promotion through selection from Assistant Chief Cashier in level 8 (Rs. 47600-151100) of the pay matrix with six years regular service in level 8 of the pay matrix”

shall be substituted by the words

“Promotion through selection from Assistant Chief Cashier in level 8 (Rs. 47600-151100) of the pay matrix with eight years regular service in level 8 of the pay matrix”

3. For the post of Chief Cashier, in column 11, the existing Note shall be renumbered as Note 1 thereof and after Note 1 as so renumbered, the following Note shall be inserted:

“Note 2: The eligibility service of ‘six years’ for promotion of incumbents holding feeder cadre posts on regular basis, shall continue to be the same on the date of notification of the amendment.”

1. (i) These rules may be called the Indian Railways Library and Information Officer, Assistant Library and Information Officer (Amendment) Rules, 2024.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the Indian Railways Library and Information Officer, Assistant Library and Information Officer Recruitment Rules, 2022, in the Schedule, for the post of Library and Information Officer, in column 11,

(a) under the heading 'By Promotion', the words

“Assistant Library and Information officer in Level-7 (Rs. 44900-142400) in the pay matrix with seven years”

shall be substituted by the words

“Assistant Library and Information officer in Level-7 (Rs. 44900-142400) in the pay matrix with nine years”

(b) under the heading 'Deputation', the words

“(ii) with seven years' regular service in level 7(Rs. 44900-142400) in the pay matrix or equivalent; and”

shall be substituted by the words

“(ii) with nine years' regular service in level 7(Rs. 44900-142400) in the pay matrix or equivalent; and”

3. For the post of Library and Information Officer, in column 11, following note shall be inserted below note 3:

“Note 4: The eligibility service of ‘seven years’ for promotion of incumbents holding feeder cadre posts on regular basis, shall continue to be the same on the date of notification of the amendment.”
