
**Sub:- Extension of currency of workcharged HAG/SAG posts
in the Construction Organisation of N.E. Railway.**

In terms of Board's sanction No. 2014E(GC)3-21(15) dated 17.02.2016 it was decided by Board to not extend the currency of the SAG post of CSTE/Con(postcode-7426) of S&T Deptt. beyond 30.06.2014 as the same was not admissible as per outlay and yardsticks. Now, Board have decided to extend the currency of the SAG post { whose SAG element is being utilized in Railway Board to operate the post of ED(Safety) (postcode- 7577) in SAG } upto 30.06.2015 against Construction outlay of S&T Deptt. of Northeast Frontier Railway for years 2014-15 & 2015-16.

2. Accordingly, sanction of the Ministry of Railways is hereby accorded, post-facto, to the extension of the currency of the SAG post of CSTE/Con (postcode-7426), currency of which was last extended upto 30.06.2014 vide Board's sanction No. 2013E(GC)3-6(77) dated 25.07.2014 for a further period upto 30.06.2016.




