
**Sub:- Extension of currency of workcharged HAG post of FA&CAO/P (PC - 12856) in Accounts Deptt. of RCF/Kapurthala.**

Sanction of the Ministry of Railways is hereby accorded post facto to the extension of currency of the workcharged HAG post of FA&CAO/P (Postcode 12856) in Accounts Deptt. of RCF/Kapurthala, last extended upto 30.6.2017 vide Board's letter No.2016E(GC)11-2(13) dt.19.01.2017, for a further period of 9 months i.e. upto 31.3.2018 chargeable to 'Ministry of Defence estimates of 90 coaches'.

2. In regard to RCF/KXH's request for extension of currency of aforesaid HA Grade workcharged post of FA&CAO/P in SA Grade since HAG element of the post was transferred to ECR to upgrade SAG post of FA&CAO(PC-5409) to HAG vide No.2013E(GC)12-7(29) dt.21.2.2013, it is clarified that as per practice in vogue, salary should be charged to parent Railway itself irrespective of the place of operation of the post. Hence, the aforesaid workcharged post has to be extended in HA Grade only.
