Sub. : Extension of currency of SAG workcharged post in the Construction Organization beyond 30.6.2014.


Ref. : S. Railway's letters No. P133/1/1/CN/SAG dt. 14.09.2015.

In terms of Board's sanction No. 2014E(GC)3-17(81) dt 30.07.2015, currency of 17 HAG/SAG workcharged posts of Construction Organization of Southern Railway has been extended upto 30.6.2015 except one workcharged SAG post of CSTE/CN/North/MS (Postcode 7428) of S&T department, which Railway was directed to surrender. This post, however, continued to be operated by the Railway without Board's sanction. Board have now decided to extend the currency of the workcharged SAG post of CSTE/CN/North/MS (Postcode 7428) of S&T department of Construction Organization for a period of one year beyond 30.6.2014 to regularize the irregular operation of this post.

2. Accordingly, sanction of the Ministry of Railways is hereby accorded, post facto, to the extension of currency of the workcharged SAG post of CSTE/CN/North/MS (Postcode 7428) of S&T department of Construction Organization beyond 30.6.2014 for a further period upto 30.6.2015.

3. Board have, however, taken a very serious view of the irregular operation of the aforesaid post despite Board's instructions to surrender the post. Railway is, therefore, advised to avoid such irregular operation of posts in future.

4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


