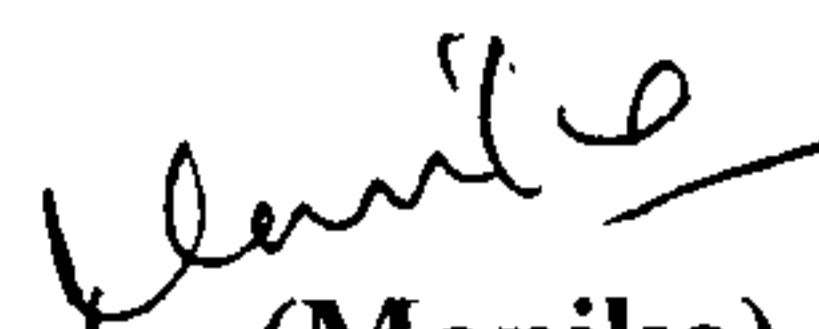
Reference above, Board have decided to extend the currency of all 33 temporary gazetted posts as mentioned in the table below, for a period upto 31.3.2017.

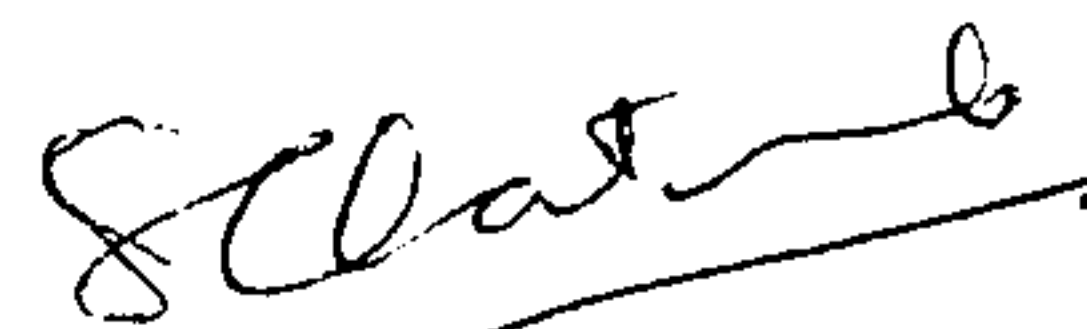

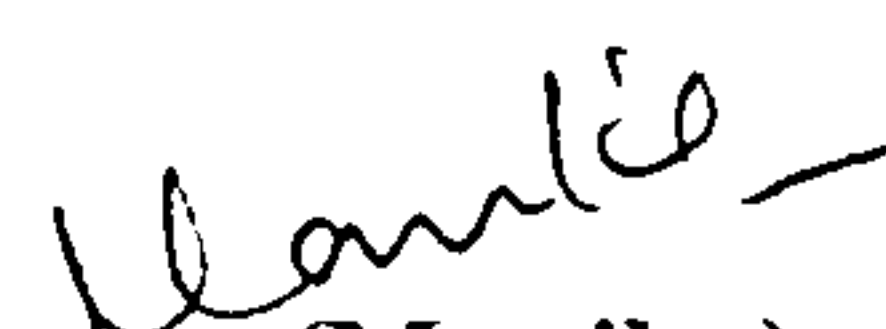
