**Sub : Transfer the HAG/IRSSE element of the work charged post of CAO/IRPMU (PC: 12585) from N.C. Railway to S.W. Railway.**

Board have decided to transfer the HAG/IRSSE element of the work charged post of CAO/IRPMU (PC: 12585) from North Central Railway to South Western Railway to upgrade the SAG/IRSSE post of CSTE/Plg.(PC: 4630) to HAG.

2. Accordingly, sanction of the Ministry of Railways is hereby accorded to transfer the HAG/IRSSE element of the work charged post of CAO/IRPMU (PC: 12585) from North Central Railway to South Western Railway to upgrade the SAG/IRSSE post of CSTE/Plg.(PC: 4630) to HAG.

3. Consequently the HAG post of CAO/IRPMU (PC: 12585) will be downgraded and operated in SAG. N.C. Railway should advise S.W. Railway immediately about the date of release of the HAG/IRSSE element under intimation to this office. The operation of the HAG/IRSSE post of CSTE/Plg. at SWR will be effective from the date the HAG/IRSSE element is released by North Central Railway or from the date of issue of transfer/posting order of the incumbent of the HAG post of CSTE/Plg./SWR (PC: 4630).

4. It may be ensured that there is no overlapping operation of HAG element of the post of CAO/IRPMU (PC: 12585) at NCR & SWR.
