**Sub : Transfer of JAG/IRTS posts.**

In terms of Board's letter No. 2019E(GC)12-90 (121) dt. 18.11.2019, JAG/IRTS post of JD/DTC/G (PC: 11RB5P001) was transferred to Northern Railway along with transfer of various posts from Railway Board. Board has now decided to restore the JAG/IRTS post of JD/DTC/G (PC: 11RB5P001) from NR to RB and to transfer the JAG/IRTS post of Dir/E&R (Traffic) (PC: 11RB5P008) from RB to NR.

2. Accordingly, sanction of Ministry of Railways is hereby accorded to the following:-

- (i) To restore the JAG/IRTS post of JD/DTC/G (PC: 11RB5P001) from NR to RB; and
- (ii) To transfer the JAG/IRTS post of Dir/E&R (Traffic) (PC: 11RB5P008) from RB to NR.

3. Operation of the JAG IRTS posts of Dir/E&R (Traffic) (PC: 11RB5P008) and JD/DTC/G (PC: 11RB5P001) at NR and RB respectively, will be effective from the dates the posts are released by RB and NR or from the date of actual operation of the posts at NR and RB, whichever is later.
