Sub: Transfer/Restoration of HAG/IRAS posts.

Sanction of Ministry of Railways is hereby accorded to the following :

- (i) Transfer of HAG/IRAS post (PC: 02RD3P001), being operated as Sr. ED/Fin/RDSO, from RDSO to ECoR to be operated as FA&CAO/CON/ECoR ;
- (ii) Restoration of HAG/IRAS post (PC: 02CN3P001), being operated as FA&CAO/CON/ECoR from ECoR to NFR to be operated as FA&CAO/CON/NFR ;
- (iii) Transfer of HAG/IRAS post (PC: 02OW3P001), being operated as PFA/COFMOW from COFMOW to SR to be operated as FA&CAO/MTP/Chennai ;
- (iv) Restoration of HAG/IRAS post (PC: 02EC3P001), being operated as FA&CAO/CON/WCR from WCR to ECR to be operated as FA&CAO/CON/ECR.

2. Operation of the posts at transferred locations will be effective from the date of release of the posts by concerned units or from the date of actual operation of the posts at the transferred locations, whichever is later.

3. Since SAG post of ED/Fin. (Old PC: 7655) was upgraded to HAG as Sr. ED/Fin., RDSO is advised to discontinue operation of SAG post (Old PC: 7655) of ED/Finance, if not done earlier and also to release the HAG post of Sr.ED/Fin. to ECoR immediately.
