**Sub: Transfer/Restoration of HAG/SAG IRSE posts.**

Sanction of Ministry of Railways is hereby accorded to the following :

- (i) Restoration of HAG/IRSE post (PC:03SE3P003), presently being operated as SDGM/NR, from NR to SER for its operation as SDGM/SER ;
  - (ii) Transfer of SAG/IRSE post (PC: 03NR4P001) from SER to RB for its operation as ED/SD-II/RB ;
  - (iii) Restoration of HAG/IRSE post (PC:03RC3P004), presently being operated as SDGM/SER, from SER to SECR for its operation as CTE/SECR;
  - (iv) Restoration of HAG/IRSE post (PC:03ER3P004), presently being operated as CTE/SECR, from SECR to ER for its operation as SDGM/ER; and
  - (v) Operation of SAG/Genl. post of SDGM/ER (PC:01ER4P001) in IRSE cadre on ER itself.
2. Operation of the posts at transferred locations will be effective from the date of release of the posts by concerned units or from the date of actual operation of the posts at the transferred locations, whichever is later.
  3. Further, one post of TADK also stands transferred from SER to Railway Board along with the transfer of SAG/IRSE post (PC: 03NR4P001) from SER to RB.
  4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
