Sub : Operation of IRSEE posts/elements.


Sanction of the Ministry of Railways is hereby accorded to :-

- (i) Transfer the HAG/IRSEE element of workcharged post of CEE/ CORE(Postcode-7381) to upgrade the revenue charged SAG/IRSEE post of CEE/SCR (Postcode-4011) to HAG &
- (ii) Transfer the HAG/IRSEE element of revenue charged post of CEE(Plg.)/ECR(Postcode- 3789) to upgrade the SAG/IRSEE workcharged post of CEE/COFMOW (Postcode- 10448) to HAG.

2. Consequently, the HAG/IRSEE workcharged post of CEE/CORE(Postcode-7381) and HAG/IRSEE revenue charged post of CEE(Plg.)/ECR(Postcode- 3789) will be downgraded and operated in SAG.

3. Operation of the SAG/IRSEE posts of CEE/SCR (Postcode- 4011) and CEE/COFMOW (Postcode- 10448) in HAG will be effective from the date(s) the HAG/IRSEE element(s) is released by CORE and ECR respectively or the HAG/IRSEE element(s) is actually operated in SCR and COFMOW, whichever is later.




