Dear Madam/Sir,

In terms of this Ministry's letter (as per attached list), you were offered appointment as Assistant Divisional Medical Officer. However, due to your inability to join the Indian Railways within the stipulated time, on grounds of pursuing Post Graduate studies, the aforesaid offer of appointment lapsed as per the terms of the letter. On your request for revival of offer of appointment as Assistant Divisional Medical Officer, the same has been examined in consultation with the Union Public Service Commission. Commission has agreed to the request for revival of offer of appointment subject to the conditions that you will accept the seniority assigned as per rules in force and serve any Zonal Railway/PU.

2. You are directed to report to the **Director General, National Academy of Indian Railways, Lalbaug, Vadodara - 390004 (Gujarat) on 20.05.2024 (Monday)** for joining formalities and probationary training. Field Training in Railway Hospitals on different Zonal Railways/PUs shall be part of Foundation Course and would in no way be treated as your Zonal Allocation. Zonal Allocation shall be finalized as per Zonal Allocation Policy in due Course. This appointment carries with it the liability to serve anywhere in India and you are liable to be posted/transferred to any part of India as per administrative requirements.

3. Your specific attention is invited to Paras 2, 3, 4, 9 and 10 of the Terms & Conditions. Formats of undertaking referred to in Para 3 to be signed on a Rs. 100/- Stamp Paper, and the Declaration referred to in Para 9 of the Terms & Conditions are to be submitted to the Director General, National Academy of Indian Railways,

Vadodara at the time of reporting for training, failing which you shall not be permitted to join.

4. The forms to be filled while reporting at National Academy of Indian Railways (NAIR), Vadodara, can be downloaded from NAIR's website link:

http://www.nair.indianrailways.gov.in/view_section.jsp?lang=0&id=0,5,765.

You are requested to bring these forms and the forms mentioned at para 3 above duly filled at the time of your reporting at NAIR, Vadodara to complete the joining formalities. In case, at any stage, it is found that any certificate/document/ testimonial, etc. furnished by you and having a bearing on your eligibility is not in order or any information/material facts having bearing on your eligibility has been hidden/ misrepresented by you, then your appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules.

5. You are required to submit your original Rotatory Internship Certificate to the Director General, National Academy of Indian Railways, Vadodara at the time of reporting for training. In the event of your failure to produce Internship Certificate at the time of reporting to the National Academy of Indian Railways clearly indicating that you have completed one year's internship, you shall not be allowed to join Railway Service. In addition, you are also required to produce all the original certificates while reporting at the Training Institute.

6. Please inform this Office as well as Director General, National Academy of Indian Railways, Vadodara through online mode within a week as per the **Format-I** attached with this letter whether you accept this offer of appointment. If you accept this offer of appointment, you should report to Director General, National Academy of Indian Railways, Vadodara on 20.05.2024 (Monday) positively.

7. If you fail to join on or before the stipulated date, the offer of appointment is liable to be cancelled. **No request for further extension in joining time on revival of offer is admissible.** On your joining at National Academy of Indian Railways, Vadodara as well as for Field Training at Railway Hospital concerned, you will not be granted any kind of long leave before completing the training.

8. If you are already serving in any Organization, you must produce 'No Objection Certificate' from the employer under whom you are serving.

9. Your appointment is provisional and subject to your character and antecedents being found satisfactory by Police/District Authorities on enquiries as may be considered necessary by the Government. For this purpose, you are required to submit your attestation form (04 copies) as available on following link to the Director General, NAIR, Vadodara at the time of reporting for joining.

If you claim to belong to SC or ST or OBC category, you may please note that "the appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channels and if the verification reveals that the claim to belong to SC or ST or OBC or not to belong to creamy layer of OBC, as the case may be, is false, the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates".

11. The other conditions for service in respect of which no specific mention has been made in this offer of appointment or in the terms and conditions of service shall be as decided by the Government (Ministry of Railways) in consultation with the Department/Ministry concerned.

Non return of the unused Railway Pass or misuse of the Railway Pass i.e. for the purpose other than for which it has been issued, will be viewed seriously and action will be initiated as per rules.

(i) **Six (06)** candidates (list attached) have been issued revived offer of appointment to the post of Assistant Divisional Medical Officer (Probationer) with the direction to report to National Academy of Indian Railways, Vadodara on 20.05.2024 (Monday).

(ii) Identification of these candidates may be done from their Aadhar UID Numbers, or any other government issued ID. He/she should be allowed to join FT only on satisfying NAIR that he/she has completed one year's (365 days) internship. Original internship certificate should invariably be verified and a photocopy thereof duly attested by National Academy of Indian Railways should be forwarded to this Ministry within 15 days of the date of joining of the candidate. Attention is also invited to paras of the offer of appointment addressed to the candidate.

(iii) The candidates allotted for training are required to execute a bond in the prescribed form. The same may be obtained from him/her as soon as he/she joins and kept in the personal file of the candidate.

(iv) The caste certificates produced by the candidates claiming to belong to SC or ST or EWS or OBC or not to belong to creamy layer of OBC are required to be verified. In case of false declaration being furnished by the candidates, appropriate action should be immediately initiated against them as per extant instructions.

(v) All the requisite certificates alongwith other documents of the above candidates may be verified by NAIR before allowing them to join.
