**Subject : Recruitment to Indian Railway Health Service (IRHS) on the basis of Combined Medical Services Examination (CMSE)-2023 - recommended by UPSC.**

Candidature of 89 candidates allotted to IRHS on the basis of CMSE 2023 by Ministry of Health & Family Welfare has been kept "Provisional" by UPSC due to non-submission of certain documents for verification.
