The President is pleased to offer you appointment as Assistant Divisional Medical Officer (Probationer) in the Indian Railway Health Service based on the recommendations made by the Union Public Service Commission on the basis of results of the Combined Medical Services Examination 2022.

- 2. You are directed to report to the **Director General**, **National Academy of Indian Railways**, **Lalbaug**, **Vadodara 390004** (**Gujarat**) on 11.03.2024 for joining formalities and probationary training. You will be provided with single accommodation at NAIR, Vadodara.
- 3. The terms and conditions of service, which will be applicable to you, as well as Bond Proforma and Declaration Form, may be downloaded from Indian Railway's official website at the following link:

http://www.indianrailways.gov.in/railwayboard/uploads/directorate/mgt\_ser/Indian\_Medical\_Services/IRMS\_301019.pdf . Your specific attention is invited to Paras 2, 3, 4, 9 and 10 of the Terms & Conditions. Formats of undertaking referred to in Para 3 to be signed on a Rs. 100/-Stamp Paper, and the Declaration referred to in the Para 9 of the Terms & Conditions are to be submitted to the Director General, National Academy of Indian Railways, Vadodara at the time of reporting for training, failing which you shall not be permitted to join.

- 4. Your continuance in Railway service shall be subject to your character and antecedents being found satisfactory by Police/District Authorities.
- 5. You are required to submit your original Rotatory Internship Certificate to the Director General, National Academy of Indian Railways, Vadodara at the time of reporting for training. In the event of your failure to produce Internship Certificate at the time of reporting to the National Academy of Indian Railways clearly indicating that you have completed one year's internship, you shall not be allowed to join Railway Service. In addition, you are also required to produce all the original certificates while reporting at the Training Institute.
- 6. If you claim to belong to SC or ST or OBC or EWS category, you may please note that "the appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channels and if the verification reveals that the claim to belong to SC or ST or EWS or OBC or not to belong to creamy layer of OBC, as the case may be, is false, your services shall be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates".
- 7. If you are already serving in any Organization, you <u>must</u> produce 'No Objection Certificate' from the employer under whom you are serving.
- 8. In case, at any stage, it is found that any certificate/ document/ testimonial, etc. furnished by you and having a bearing on your eligibility is not in order or any information/material facts having bearing on your eligibility has been hidden/ misrepresented

by you, then your appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules.

- 9. Please inform this Office as well as Director General, National Academy of Indian Railways, Vadodara through online mode within a week as per the **Format-I** attached with this letter whether you accept this offer of appointment. If you accept this offer of appointment, you should report to Director General, National Academy of Indian Railways, Vadodara on 11.03.2024 (Monday) positively.
- 10. If you fail to join on the stipulated date, the offer of appointment is liable to be cancelled. On your joining at National Academy of Indian Railways, Vadodara, you will not be granted any kind of long leave before completing the training. Only justified cases supported with documentary proof will be considered for grant of extension in joining time which will be subject to DoP&T's OM No. 35015/2/93-Estt(D) dated 09.08.1995 and the same will not be granted as a matter of right. In your own interest you should pursue your request for extension in joining time. Non-receipt of letter granting extension in joining time or non-receipt of any type of communication from Ministry of Railways in this regard, etc. will not be considered as a reason for not joining and subsequently requesting for revival of offer. In terms of DoP&T's OM No. 35015/2/93-Estt(D) dated 09.08.1995, the offer of appointment lapses after expiry of six months from the date of offer of appointment. (in this case offer would lapse automatically on 30.07.2024)
- 11. If you are <u>already</u> admitted to a Post-Graduation Course in Medical Sciences & wish to pursue the same and join the service after its completion, please intimate the same to Deputy Director, E(GR)-II Branch, Room No.2-A Rail Bhavan, New Delhi-110001 through Registered/Speed Post and on email id- <u>ddegr@rb.railnet.gov.in</u> within 30 days from the date of issue of this letter <u>as per the Format-II attached with this letter</u>. However, after completion of Post Graduation, formal request for revival should be received in this office at least 45 days before the lapse of three years duration from the date of offer of appointment. The revival of offer will be subject to DoP&T's OM No.9/23/71-Estt.(D) dated the 6th June, 1973 or any other instruction to be issued from time to time. ### 1. The Director General, National Academy of Indian Railways, Vadodara.
