
Sub:- Apprentices Act, 1961--Raising debits
to Ministry of Human Resource Department.

.....

Under the clause 8(c) of section 9 of the Apprentice Act, 1961, as amended in 1973, the cost of stipends in connection with practical training imparted to graduate or technician, technician (Vocational) apprentices, shall be borne by the Central Govt. (i.e. Ministry of Human Resource Development) and the employer (in this case, Ministry of Railways) in equal shares.

Railways/Production Units should, therefore as a rule, pass on the debits regularly to the Ministry of Human Resource Development, under intimation to this Ministry. In case debits have not/raised for any particular period in the past, the same may be done now and reasons for not having done so may be advised to Board.
