

**Sub:-Benefit of revised scale of Pay to Railway servants who  
were on leave from a date prior to 01.01.96 and died on or  
after 01.01.96 without resuming the duties.**

References have been received from a few Railways seeking clarification regarding the applicability of the revised pay scales of Railway Services (Revised Pay) Rules, 1997 to Railway servants who were on leave from a date prior to 01.01.96 and died on or after 01.01.96 without resuming duty.

2. In this connection it is clarified that in terms of Note 3 below Rule 7 of Railway Services (Revised Pay) Rules, 1997 if a Railway Servant was on leave on 01.01.96, the benefits of revised scales of pay are admissible to him from the date he resumes duty. In such cases the pay is required to be fixed in the revised scale on 01.01.96 on notional basis and actual benefit of pay allowed from the date of resuming duty. However, it has been held that in cases where Railway servants died on or after 1.1.96 while on leave without resuming their duties, they shall be entitled to the benefit of the revised pay rules and their cases may be decided in terms of Note 2 under Rule 6 of Railway Services (Revised Pay) Rules, 1997.



विषय:- उन रेल सेक्कों को संशोधित वेतनमान का लाभ देना जो 1.1.96 से पहले छुट्टी पर थे तथा ड्यूटी पर पुनः कार्यभार संभालने से पूर्व ही जिनकी 1.1.96 को अथवा इसके बाद मृत्यु हो गई.

कुछ रेलों से पत्र प्राप्त हुए हैं जिनमें उन रेल सेक्कों जो 1.1.96 से पहले छुट्टी पर थे तथा ड्यूटी पर पुनः कार्यभार संभालने से पूर्व ही 1.1.96 को अथवा उसके बाद जिनकी मृत्यु हो गई थी, पर रेल सेवा § संशोधित वेतन § नियम, 1997 के संशोधित वेतनमान लागू करने के संबंध में स्पष्टीकरण मांगे गये हैं.

2. इस संबंध में यह स्पष्ट किया जाना है कि रेल सेवा § संशोधित वेतन § नियम, 1997 के नियम 7 के नीचे नोट 3 के अनुसार यदि कोई रेल सेक्क 1.1.96 को छुट्टी पर था तो उसे संशोधित वेतनमानों के लाभ ड्यूटी पर पुनः कार्यभार संभालने की तारीख से स्विकार्य होंगे. ऐसे मामलों में वेतन नोशनल आधार पर 1.1.96 को संशोधित वेतनमान में निर्धारित किया जाना अपेक्षित है तथा वेतन का वास्तविक लाभ पुनः कार्यभार संभालने की तारीख से दिया जाएगा. बहरहाल, उन मामलों में जहां रेल सेक्क की छुट्टी के दौरान <sup>पुनः</sup> कार्यभार संभालने से पूर्व ही 1.1.96 को अथवा इसके बाद मृत्यु हो जाती है, वे संशोधित वेतन नियम के लाभों के लिए पात्र होंगे तथा उनके मामले में निर्णय रेल सेवा § संशोधित वेतन § नियम, 1997 के नियम 6 के अंतर्गत नोट 2 के अनुसार लिया जाएगा.
