Sub : Introduction of Additional pay scales – recommendations of V CPC


In pursuance of the recommendations of the Vth Central Pay Commission, an additional scale of Master Cook in Catering, Medical and Canteen Departments in the grade of Rs.4500-7000 was introduced vide Board's letter No.PC-V/98/I/11/18(A), S.No.PC-V/75 dated 10.5.98.

1.1 Consequent upon the revision of pay scales of the Artisan grade I and Master Craftsman in Artisan Cadre to Rs.4500-7000 and Rs.5000-8000 respectively vide Board's letter No.PC-V/97/R-II/17, S.No.PC-V/141 dated 24.11.98, the Staff Side had raised the demand for revision of pay scales of Master Cook on similar pattern. The matter has been carefully considered and the Ministry of Railways, with the approval of the President have decided to grant the following pay scales to Head Cooks and Master Cooks in Catering Department, Master Cooks in Medical Department and Master Cooks in the departmental Canteens.

पांचवें केंद्रीय वेतन आयोग की सिफारिशों के अनुसरण में बोर्ड के दिनांक 10.5.98 के पत्र सं० पीसी-5/98/आई/11/18 {प}, क.सं.पीसी-5/75 द्वारा खानपान, चिकित्सा तथा कैंटीन विभागों में 4500-7000 ₹ के ग्रेड में मास्टर कुक के अतिरिक्त वेतनमान लागू किया गया था.

1.1 बोर्ड के दिनांक 24.11.98 के पत्र सं० पीसी-5/97/आर-11/17, क.सं.पीसी-5/141 द्वारा आर्टिसन संवर्ग में आर्टिसन ग्रेड-1 तथा मास्टर काफ्ट्समैन के वेतनमानों में क्रमशः 4500-7000 ₹ तथा 5500-8000 ₹ के संशोधन के परिणामस्वरूप इसी पैटर्न पर मास्टर कुक के वेतनमानों में संशोधन करने की मांग कर्मचारियों की ओर से की गई थी. मामले पर ध्यानपूर्वक विचार किया गया है तथा रेल मंत्रालय ने राष्ट्रपति के अनुमोदन से खानपान विभाग में हेड कुर्को तथा मास्टर कुर्को, चिकित्सा विभाग में मास्टर कुर्को तथा विभागीय कैंटीनों में मास्टर कुर्को के निम्नलिखित वेतनमान मंजूर करने का विनिश्चय किया है :-




