

No. 45/57/97-P&PW(C) dated 19 December, 1997 on the above mentioned subject read alongwith all subsequent changes/modifications/clarifications etc., shall apply mutatis- mutandis to such Railway Pensioners/Family Pensioners also who are governed under the C.G.H.S.




