**Sub : Grant of Overtime Allowance to Railway employees consequent upon revision of pay scales and allowances**


**Ref : Board's letter of even number dated 9.2.98**

Consequent upon revision of pay scales w.e.f.1.1.96, instructions were issued on the subject of rate of Overtime Allowance in reference to revised pay scales vide Board's letter of even number dated 9.2.98. The question as to whether Dearness Allowance should also be included within the purview of emoluments in the case of employees who are paid Over Time Allowance under Rule 1505 R-II (1987 Edition) read together with Railway Board's letter No.E(LL)80/AT/FAC/1-13 dated 27.2.1982 has been under consideration. It has now been decided that Over Time Allowance payable under Rule 1505 R-II (1987 Edition) shall continue to be computed on the basis of revised rates of pay plus Dearness Allowance.

2. The Dearness Allowance forming part of the emoluments as clarified above for the purpose of computation of rates of Over Time Allowance may be taken into consideration with effect from the dates and at the rates, notified from time to time.

3. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.





1.1.96 से वेतनमानों में संशोधन के फलस्वरूप, बोर्ड के दिनांक 9.2.98 के समसंख्यक पत्र द्वारा संशोधित वेतनमानों के संदर्भ में समयोपरि भत्ते की दर के विषय पर अनुदेश जारी किए गये थे. इस प्रश्न पर कि क्या उन कर्मचारियों जिन्हें रेलवे बोर्ड के दिनांक 27.2.1982 के पत्र सं.ई ॥ एल एल ॥ 80/पटी/पफ प सी/1-13 के साथ पठित नियम 1505 आर-11 ॥ 1987 संस्करण ॥ के अंतर्गत समयोपरि भत्ते का भुगतान किया जाता है, के मामले में परिलब्धियों में मंहगाई भत्ते को भी शामिल किया जाए, विचाराधीन है. अब यह विनिश्चय किया गया है कि नियम 1505 आर-11 ॥ 1987 संस्करण ॥ के अंतर्गत देय समयोपरि भत्ता वेतन की संशोधित दरें जमा मंहगाई भत्ते के आधार पर परिकल्पित किया जाता रहेगा.

2. मंहगाई भत्ता जो परिलब्धियों का भाग है जैसा कि ऊपर स्पष्ट किया गया है, समयोपरि भत्ते की दरें के परिकल्पन के लिए समय-समय अधिसूचित तारीखों से तथा दरें पर हिसाब में लिया जाए.


