The issue relating to grant of Transport Allowance to blind or physically handicapped railway employees who are availing the facility of First Class Residential Card Passes and were also getting the Conveyance allowance earlier, has been considered by the Railway Board in consultation with the recognised Federations and it has been decided that railway employees who are blind or are orthopaedically handicapped with disability of lower extremities would be entitled to grant of Transport Allowance at normal rates as applicable under Board's letter of even number dated 16.12.97, even if they are availing the facility of FRC.

2. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

नेत्रहीन अथवा शारीरिक रूप से विकलांग उन रेल कर्मचारियों को, जो प्रथम श्रेणी के आवासीय कार्ड पास की सुविधा का उपयोग कर रहे हैं और किराया भत्ता प्राप्त कर रहे थे, परिवहन भत्ता प्रदान करने से संबंधित मुद्दे पर स्वीकृत फेडरेशनों के परामर्श से रेलवे बोर्ड द्वारा पहले विचार किया गया है और यह विनिश्चय किया गया कि जो रेल कर्मचारी नेत्रहीन हैं अथवा निम्ने अंगों की विकलांगता से ग्रस्त हैं, वे भी बोर्ड के दिनांक 16.12.97 के समसंख्यक पत्र के तहत यथा लागू सामान्य दरों पर परिवहन भत्ता प्राप्त करने के पात्र होंगे, भले ही वे प्रथम श्रेणी के आवासीय कार्ड पास की सुविधा का उपयोग नहीं कर रहे हों.
