Sub : Re-distribution of posts of Assistant Health Officers(AHOs).

Ref : Board's letter No. PC-V/97/I/11/2 dated 8.4.99 and 21.7.99.

Fortythree posts of Assistant Health Officers in Gr. 'B' scale of Rs. 7500-12000, including one each for the zonal HQ and Zonal Hospital, had been sanctioned by upgrading the equivalent number of posts in apex group 'C' scale of Rs. 7450-11500 vide Board's letters referred to above. The question of change in the pattern of distribution of posts of AHOs on the Zonal Railways has been under examination of the Board following the receipt of suggestions from one of the Railways. The matter has been examined and it has been decided that the posts earmarked for Headquarters office and Zonal Hospital may also be operated in Divisions, if required as per local needs.

बोर्ड के उपर्युक्त पत्रों के तहत 7450-11,500 रु. के सर्वोच्च ग्रुप 'सी' वेतनमान में तैतालीस पदों को अपग्रेड करके 7500-12,000 रु. के ग्रुप 'बी' वेतनमान में सहायक स्वास्थ्य अधिकारियों के पद समतुल्य संख्या में, प्रत्येक क्षेत्रीय मुख्यालय और क्षेत्रीय अस्पताल के लिए एक-एक पद, स्वीकृत किए गए थे. एक क्षेत्रीय रेलवे से सुझाव प्राप्त होने के बाद, क्षेत्रीय रेलों पर सहायक स्वास्थ्य अधिकारियों के पदों के वितरण की पद्धति में परिवर्तन करने से संबंधित प्रश्न की बोर्ड द्वारा जांच की जा रही थी. मामले की जांच की गई है और यह विनिश्चय किया गया है कि स्थानीय आवश्यकताओं के कारण यदि अपेक्षित हो तो मुख्यालय और क्षेत्रीय अस्पताल के लिए निर्धारित पदों को मंडलों में भी परिचालित किया जा सकता है.

इससे पश्चिम रेलवे के दिनांक 26.6.2001 के पत्र सं. ई (जी) 1024/10 का निपटारा हो जाता है.
