In continuation of Ministry of Railways letter of even number dated 16.11.2000 (S.No.PC-V/285 RBE No.198/2000) revising the rate of Dearness Allowance, w.e.f. 1.1.96 to 1.1.2000 in respect of Railway Servants who continue to draw their pay and emoluments in the pre-revised scale of pay, the revised rate of Dearness Allowance w.e.f. 01.07.2000 would be as follows:-

**Rate of Dearness Allowance**

Date from which payable	pay up to Rs.3,500 p.m.	Pay above Rs.3,500 and Up to Rs.6,000 p.m.	Pay above Rs.6,000 p.m.
1.7.2000	251%	188%(Rs.8785)	163%(Rs.11280)

NOTE: Amount within brackets represent the minimum amount payable per month as Dearness Allowance to employees in the different pay ranges.

2. All other conditions as laid down in the letter dated 16.11.2000 will continue to apply.




