Sub: Allotment of higher pay scales to Stock Verifiers.

Consequent upon Ministry of Finance O.M. No. 6/82/E III(B)/91 dated 28.2.2003, Ministry of Railways have already allotted the improved pay scale to Accounts Staff vide Board's letter No. PC-V/98/I/11/23 dated 7.3.2003. However, this has upset the relativity of Stock Verifiers vis-à-vis Accounts Staff. While advising about the improved pay scale to Accounts Staff Ministry of Finance in their ibid letter has also indicated that the improved pay scale would also be available to equivalent posts in Accounts Department.

2. The matter has accordingly been reviewed and in partial modification of Ministry of Railways' letter No. PC-V/98/I/11/18(Pt) dated 17.8.1998 the President is pleased to grant the following pay scales to the Stock Verifiers -

Category	Pay scale allotted earlier (Rs.)	Improved pay scales (Rs.)
Stock Verifiers	5000-8000	5500-9000
Sr. Stock Verifiers	5500-9000	6500-10500

3. Henceforth, the Junior Accounts Assistants working as Stock Verifiers shall not be paid any special allowance. However, Accounts Assistants working as Stock Verifiers in the identical pay scale shall continue to draw special allowance at the same rate as admissible now.

4. The improved pay scales to Stock Verifiers shall be granted on notional basis with effect from 01.01.96 and actual payment prospectively from 19.2.2003, similar in effect to what has been given to the Accounts staff. Special allowance being


वित्त मंत्रालय के 28.2.2003 के का. जा. सं.6/82/ई III (बी)/91 के परिणामस्वरूप रेल मंत्रालय ने बोर्ड के 7.3.2003 के पत्र सं. पी सी-V/98/आई/11/23 के अनुसार पहले से ही लेखा कर्मचारियों को संशोधित वेतनमान आबंटित कर दिए हैं. बहरहाल, इससे स्टॉक सत्यापकों तथा लेखा कर्मचारियों की सापेक्षता गड़बड़ हो गई है. लेखा कर्मचारियों को संशोधित वेतनमान प्रदान करने संबंधी सलाह देते समय वित्त मंत्रालय ने अपने उपर्युक्त पत्र में यह भी उल्लेख किया है कि संशोधित वेतनमान लेखा विभाग में समतुल्य पदों को भी उपलब्ध कराए जाएंगे.

2. तदनुसार मामले की जांच की गई है और रेल मंत्रालय के 17.8.1998 के पत्र सं. पी सी-V/98/आई/11/18 (पार्ट) में आंशिक आशोधन करते हुए राष्ट्रपति जी सहर्ष स्टॉक सत्यापकों को निम्नलिखित वेतनमान प्रदान करते हैं :-
