विषय : लेखा कर्मचारियों के लिए संशोधित वेतनमान लागू करना - दूसरा विकल्प देना.

रेल लेखा कर्मचारियों तथा स्टाक सत्यापकों को संशोधित वेतनमान प्रदान करने संबंधी रेल मंत्रालय के क्रमशः 7.3.03 के समसंख्यक पत्र तथा 25.6.03 के पत्र सं. पी सी-V/97/आई/11/14 को लागू किए जाने के परिणामस्वरूप लेखा कर्मचारियों तथा स्टाक सत्यापकों को संशोधित वेतनमान दिए जाने पर रेल कर्मियों को विकल्प प्रदान करने के लिए क्षेत्रीय रेलों से पत्र प्राप्त हुए हैं.

2. रेलवे बोर्ड के 29.5.98 के पत्र सं. पी सी-V/98/आई/6/3 को ध्यान में रखते हुए इस मामले की जांच की गई है और यह विनिश्चय किया गया है कि रेल लेखा कर्मचारी तथा स्टाक सत्यापक 1.1.96 के बाद मिलने वाली उनकी वेतनवृद्धि की तारीख से संशोधित वेतनमान में अपना वेतन निर्धारित कराने के लिए नया विकल्प दे सकते हैं.

3. विकल्प इन आदेशों के जारी होने की तारीख से तीन माह की अवधि के भीतर दिए जाए. एक बार दिया गया विकल्प अंतिम होगा.



**Sub:- Implementation of improved pay scales to
Accounts staff –revision of option.**

Consequent to implementation of Ministry of Railways' letter of even number dated 07.3.03 and letter No. PC-V/97/I/11/14 dated 25.6.03 granting improved pay scales to Railway Accounts staff and Stock Verifiers respectively; references have been received from Zonal Railways for grant of option to Railway servants on implementation of the improved pay scales to Accounts staff & stock verifiers.

2. The matter has been examined in the light of Railway Board's letter No. PC-V/98/I/6/3 dated 29.5.98 and it has been decided that Railway Accounts staff and Stock Verifiers can exercise a fresh option to get their pay fixed in the improved pay scale from the date of their increment, falling after 1.1.96.

3. Option shall be exercised within a period of three months from the date of issue of these orders. Option once exercised shall be final.


