Sub : Payment of Dearness Allowance to Railway employees - Revised Rates effective from 1.1.2005

Reference to this Ministry's letter of even number dated 27.9.2004 (S.No.PC-V/431 RBE No.211/2004) on the subject mentioned above. The President is pleased to decide that the Dearness Allowance payable to Railway employees with effect from 1st January, 2005 shall stand modified as follows: -

Date from which payable	Rate of Dearness Allowance per month
1.01.2005	17% of pay

2. The provisions contained in Paras 3 and 4 of this Ministry's letter No.PC-V/97/1/7/14 dated 16.10.1997 (S.No.PC-V/3, RBE No.139/97) shall continue to be applicable, while regulating Dearness Allowance under these orders.
3. The additional instalment of Dearness Allowance payable under these orders shall be paid in cash to all Railway employees. The arrears may be charged to the salary bill for April, 2005 and no honorarium is payable for preparing separate bill for this purpose.
4. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.



2. इस संबंध के दिनांक 16.10.97 (कम संख्या पी.सी.-V/3, आर बी.ई.सं:-139/97) के समसंख्यक पत्र के पैरा 3 और 4 में निहित उपबन्ध इन आदेशों के अन्तर्गत महंगाई भत्ते का विनियमन करते समय लागू किए जाते रहेंगे .
3. इन आदेशों के तहत देय महंगाई भत्ते की अतिरिक्त किश्त का भुगतान समस्त रेल कर्मचारियों को नकद रूप में किया जाएगा . बकाया अप्रैल 2005 के वेतन बिल में प्रभारित किया जाए इस प्रयोजन के लिए अलग से बिल बनाने के लिए कोई मानदेय भुगतान नहीं किया जाएगा .
