**Sub: Upgradation of 80% of posts of Group 'B' officers in RDSO from the  
scale of Rs.7500-12000 to Rs.8000-13500**

In view of RDSO attaining the status of a Zonal Railway w.e.f. 01-01-2003 and subsequent grant of pay scale of Rs.7500-12000 to Group 'B' officers of RDSO on regular basis w.e.f. 01-01-2003, it has been decided that the 80:20 Scheme notified for Group 'B' officers of all Organised Services other than Accounts Department of the Zonal Railways vide Notification with GSR No. 357(E) dated 25.4.2003 circulated vide Board's letter No.PC-V/97/I/EC/1 dated 30-4-2003 would apply mutatis mutandis to RDSO also.

2. The Scheme would apply to Group 'B' officers of Organised Services in RDSO and would be subject to the outcome of the Writ Petition No. 3866/98 pending before the Hon'ble High Court of Delhi.






