Sub: Grant of Fixed Medical Allowance @ Rs.100 p.m. to the Railway pensioners/family pensioners-Clarification-reg.

Subsequent to the issue of Board's letter No. PC-V/98/1/7/1/1 dated 7-2-2008, references were received from pensioners/family pensioners and banks seeking clarification as to whether those pensioners/family pensioners who are members of RELHS and availing OPD facility are also eligible for the Fixed Medical Allowance.


2. The matter has been examined and in reference to the Board's letter dated 7-2-2008 *ibid*, it is clarified that since actual enrolment under the Health Scheme is not mandatory, those pensioners/family pensioners who, in terms of Board's letter No.97/H/28/1 dated 23-10-97, are eligible to become members of the Scheme but are not actually enrolled are also entitled for grant of Fixed Medical Allowance. Pensioners/family pensioners who possess RELHS card & avail OPD facility are NOT entitled for Fixed Medical Allowance, whereas those who possess RELHS card but do not avail OPD facility (except in cases of chronic diseases, as defined in Board's letter No.2006/H/DC/JCM dated 12-10-2006) are entitled for Fixed Medical Allowance.

3. Further, FMA and arrears of FMA would continue to be paid, as earlier, to pensioners/family pensioners only after submission of the enclosed undertaking form to the Pension Disbursing Authority (PDA) thereby implying that fulfillment of the following two conditions is mandatory for becoming admissible for FMA:-

- (i) the pensioner/family pensioner is residing beyond 2.5 kms from the nearest health unit;
- (ii) the pensioner/family pensioner is not availing the facility of OPD (except in cases of chronic diseases as mentioned in para 2 above).


बोर्ड के 07.02.2008 के पत्र सं. पीसी-V/98/आई/7/1/1 के जारी होने के बाद, पेंशनभोगियों/पारिवारिक पेंशनभोगियों और बैंकों से संदर्भ प्राप्त हुए थे, जिनमें स्पष्टीकरण मांगा गया था कि वे पेंशनभोगी/पारिवारिक पेंशनभोगी जो रे.क.उ.स्वा.यो. के सदस्य हैं और जो ओपीडी सुविधा का लाभ उठा रहे हैं, निर्धारित चिकित्सा भत्ते के लिए भी पात्र हैं।

2. मामले की जांच की गई है और बोर्ड के उपर्युक्त 07.02.2008 के पत्र के संदर्भ में, यह स्पष्ट किया जाता है, चूंकि स्वास्थ्य योजना के अंतर्गत वास्तविक पंजीकरण अनिवार्य नहीं है, वे पेंशनभोगी/पारिवारिक पेंशनभोगी जो बोर्ड के 23.10.97 के पत्र सं. 97/एच/28/1 के अंतर्गत योजना के सदस्य बनने के पात्र हैं, परंतु वास्तव में पंजीकरण नहीं करवाया है, निर्धारित चिकित्सा भत्ता प्रदान करने के भी पात्र हैं। पेंशनभोगी/पारिवारिक पेंशनभोगी जिसके पास रे.क.उ.स्वा.यो. कार्ड है और जो ओपीडी सुविधा का लाभ उठा रहे हैं, वे निर्धारित चिकित्सा भत्ते के लिए पात्र नहीं है, जबकि वे पेंशनभोगी जिनके पास रे.क.उ.स्वा.यो. कार्ड है परंतु ओपीडी सुविधा का लाभ नहीं उठा रहे (बोर्ड के 12.10.2006 के पत्र सं. 2006/एच/डीसी/जेसीएम में यथा दर्शाए अनुसार पुरानी बीमारियों के मामलों को छोड़कर) हैं, निर्धारित चिकित्सा भत्ते के पात्र हैं।

3. इसके अलावा, केवल पेंशन वितरण प्राधिकरण (पीडीए) को संलग्न वचनबद्धता के प्रस्तुत करने के बाद पेंशनभोगी/पारिवारिक पेंशनभोगी को निर्धारित चिकित्सा भत्ते एवं निर्धारित चिकित्सा भत्ते के बकायों का भुगतान पहले की भांति किया जाएगा जिससे यह स्पष्ट हो जाए कि निर्धारित चिकित्सा भत्ते के लिए अनिवार्य निम्नलिखित दो शर्तें पूरी हो रही हैं:-

- (i) पेंशनभोगी/पारिवारिक पेंशनभोगी निकटवर्ती स्वास्थ्य इकाई से 2.5 कि.मी. से अधिक की दूरी पर रहते हैं।
- (ii) पेंशनभोगी/पारिवारिक पेंशनभोगी ओपीडी की सुविधा का लाभ नहीं उठा रहे (ऊपर उल्लिखित पैरा 2 में दर्शाए गए अनुसार पुरानी बीमारी को छोड़कर)।
