
Ref: Railway Board's letter of even number dated 30-9-2019 (RBE No. 163/2019)

Para 1 of the letter referred above may be read as under:

“The issue regarding grant of financial upgradation under MACPS to Jr. Cashier by not reckoning their appointment/promotion from Sr. Shroff/JAA/Sr. Clerk to Jr. Cashier's post has been under consideration. Since appointment/promotion from Sr. Shroff/JAA/Sr. Clerk to Jr. Cashier's post involves promotion from one cadre to another cadre carrying same payscale/Grade Pay without benefit of pay fixation, it has now been decided in consultation with Finance Directorate and Establishment Directorate of Railway Board that while regulating MACP benefits to such staff, the appointment from the post of Sr. Shroff/JAA/Sr. Clerk to the post of Jr. Cashier should not be construed as promotion and, therefore, may not be reckoned for the purpose of grant of financial upgradation under MACPS”.

2. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

विषय: सीनियर श्रॉफ/जेएए/सीनियर क्लर्क के पद से पदोन्नत हुए जूनियर कैशियर को एमएसीपीएस के अंतर्गत वित्तीय उन्नयन प्रदान करने के संबंध में स्पष्टीकरण।

संदर्भ: रेलवे बोर्ड का दिनांक 30-9-2019 का समसंख्यक पत्र (आरबीई सं. 163/2019)

उक्त संदर्भित पत्र का पैरा 1 निम्नानुसार पढ़ा जाए:

“जूनियर कैशियर को एमएसीपीएस के अंतर्गत वित्तीय उन्नयन प्रदान करने में उनके सीनियर श्रॉफ/जेएए/सीनियर क्लर्क के पद से जूनियर कैशियर के पद को नियुक्ति/पदोन्नति में न गिने जाने के मुद्दे पर विचार किया जा रहा है। चूंकि सीनियर श्रॉफ/जेएए/सीनियर क्लर्क के पद से जूनियर कैशियर के पद पर नियुक्ति/पदोन्नति में वेतन निर्धारण का लाभ दिए बिना समान वेतनमान/ग्रेड वेतन में एक संवर्ग से दूसरे संवर्ग में पदोन्नति शामिल है, इसलिए रेलवे बोर्ड के वित्त निदेशालय और स्थापना निदेशालय के परामर्श से अब यह विनिश्चय किया गया है कि इन कर्मचारियों को एमएसीपी के लाभ प्रदान करते समय सीनियर श्रॉफ/जेएए/सीनियर क्लर्क के पद से जूनियर कैशियर के पद पर नियुक्ति को पदोन्नति नहीं माना जाएगा और इसलिए एमएसीपीएस के अंतर्गत वित्तीय उन्नयन प्रदान करने के प्रयोजन के लिए नहीं गिना जाएगा”।

2. इसे रेल मंत्रालय के वित्त निदेशालय की सहमति से जारी किया जा रहा है।


