- 2. The issue has been deliberated upon in detail in consultation with concerned directorate(s) taking into account certain recent judgments regarding grant of additional increments (qualification pay) to the nursing staff.
- 3. Now, it is clarified that the rate of 'two' additional increments granted to eligible nursing staff as per Para -160 of IREM Vol.I (Revised Edition 1989) and as per Board's letter RBE No. 33/2012 will be revised in terms of 7th CPC pay structure as per the methodology of revision given in Ministry of Health & Family Welfare's Order No. F. No. Z. 28015/53/2017-N dated 12.11.2020 (copy enclosed as Annexure-I) till such time the relevant provision in IREM will apply. Except revision of rate of 'additional increments' there are no other changes in the scheme prevailing in Railways.

Oualification Pay to the eligible Nursing Staff working in the Central Government Hospitals/ Institution under the Ministry of Health and Family Welfare and other Ministries/Departments was being granted as per instructions contained in this Department's OM No.Z.28016/8/87-PMS dated 23.03.1988, OM No. Z.28015/1/2000-PMS dated 23.12.2002, OM No.A.11017/4/2008-N dated 15.1.2010 (copies enclosed).

- Consequent upon the implementation of CCS (RP) Rules, 2016, the matter 2. regarding continuation of Qualification Pay and the quantum of the Qualification Pay to the eligible Nursing Staff working in the Central Government Hospitals/ Institutions under the Ministry of Health and Family Welfare and other Ministries/ Departments of the Government of India, was reviewed in consultation with Department of Personnel & Training and Department of Expenditure.
- It has been decided to continue the scheme. The Qualification Pay in the form of 3. one/two additional increment(s) (non-absorbable) in the applicable pay level of the Pay Matrix of 7th CPC, as specified in the Rule 9 of the CCS (RP) Rules, 2016, shall be applicable w.e.f. 01.01.2016 to the eligible nursing personnel after acquiring additional qualification which may be regulated in accordance with the existing terms and conditions stipulated in the M/o Health and FW OM No.A.11017/4/2008-N dated 15.1.2010 and letter No.Z.28015/53/2017-N dated 09.09.2019.
- The method for grant of increments in the 7th CPC's Pay Matrix may be followed as per the similar stipulations given in DoPT O.M. No. 1/7/2017-Estt. (Pay-I) dated 24.07.2020 applicable to Stenographers of Subordinate Offices (copy enclosed).

Advance increments granted to Stenographers of Subordinate Offices on qualifying speed test in shorthand at 100/120 w.p.m., in the 7th CPC Scenario-reg.

In accordance with the provisions contained in Department of Expenditure's OM No. 7(31)E-III(A)/75 dated 04.10.1975 and this Department's OM No. 18/44/88-Estt.(Pay-I) dated 14.08.1989 and OM No. 1/9/98-Estt.(Pay-I) dated 30.01.2001, Stenographers of Subordinate Offices were granted one or two advance increments for qualifying speed test in shorthand at 100/120 wpm. This Department vide OM No. 18/44/88-Estt.(Pay-I) dated 07.12.2009 provided that these advance increments should be treated as pay for all purposes. Further, due to the introduction of Grade Pay and Pay Band system, consequent to the implementation of CCS (RP) Rules, 2008, this Department vide OM No. 1/1/2010-Estt.(Pay-I) dated 06.12.2012 had clarified the manner in which these advance increment(s) are to be computed.

- Consequent upon the implementation of CCS (RP) Rules, 2016, the system of Pay Band and Grade Pay has been replaced by the Pay Matrix. The manner in which the advance increment(s) are to be computed and the guidelines for granting these advance increments to Stenographers of Subordinate Offices on qualifying speed test in shorthand at 100/120 w.p.m., in the 7th CPC Scenario, have been considered in this Department, in consultation with Department of Expenditure.
- The President is pleased to decide that in supersession of all the existing 3. orders/OMs/instructions/guidelines on the subject of granting the advance increment(s) to Stenographers of Subordinate Offices on qualifying speed test in shorthand at 100/120 w.p.m., w.e.f. 01.01.2016 the advance increments shall be regulated as under:
 - The stenographer who is recruited on the basis of speed test in the shorthand at 80 w.p.m. may be granted one advance increment on qualifying speed test in shorthand at 100 w.p.m. and one more advance increment on qualifying speed test in shorthand at 120 w.p.m. while in service. However, if a Ballon Rodo stenographer who is recruited on the basis of speed test in the short hand at 80 w.p.m. directly qualifies the speed test in shorthand at 120 w.p.m. while in service, he/she may be granted two advance increments.

- (ii) The stenographer, who is recruited on the basis of speed test in the shorthand at 100 w.p.m., may be granted one advance increment on qualifying speed test in shorthand at 120 w.p.m. while in service.
- (iii) These speed tests shall be conducted by properly constituted Authorities including Departmental Authorities.
- (iv) These advance increments shall be granted from the date of passing the test.
- (v) These advance increments shall not be absorbed in future increments and the date of next increment after the grant of these advance increments shall remain the same. No option for fixation of pay from the Date of Next Increment shall be available/allowed for fixation of pay on account of these advance increments.
- (vi) The amount of these advance increments shall be treated as a separate element in addition to the basic pay and it should be counted as pay for all purposes. Further, once these advance increments are taken into account for the purpose of fixation of pay on promotion or being placed in a higher scale on grant of MACP or due to revision of Pay Scale or Pay Structure etc., these advance increments no longer continue as a separate element.
- (vii) In respect of the stenographers, who become eligible for grant of these advance increments consequent upon the implementation of CCS (RP) Rules, 2016, they may be granted one/two advance increments (as the case may be) in the vertical Level, in which the Government Servant is placed on the date of passing the test, as illustrated below:

Sir.

I am directed to refer to your letter No.A.I.G.N.F./35/2018 dated 11.06.2018 on the subject mentioned above and to furnish the following clarification obtained from DoPT:

- i. Those Nursing Officer who has joined with GNM (Diploma) before August, 2014 and has acquired B.Sc/B.Sc.(Hon)/Post Basic B.Sc in Nursing prior to August, 2014 [i.e. date of amendment of RRs] may be eligible for QP, as these Nursing Officer were recruited on the basis of the extant guidelines before August, 2014 [i.e. date of amendment of RRs], according to which the basis requirement, as per then RRs, was GNM(Diploma).
- ii. However, those who have been recruited prior to August, 2014 [i.e. date of amendment of RRs] and have attained the B.Sc/ B.Sc.(Hon) B.Sc in Nursing after August, 2014 [i.e. date of amendment of RRs] may **not** be eligible, as by the time they had acquired the said qualifications the RRs had been amended.
- iii. Those Nursing Officer who has joined after August, 2014 [i.e. date of amendment of RRs] with B.Sc/B.Sc(Hon)/ Post Basic B.Sc in Nursing may **Not** be eligible for QP, as according to the extant guidelines issued by MoHFW on this subject, the QP is not granted on recruitment to the post for the qualification acquired is an essential qualification as per RRs.

The undersigned is directed to any that the question of grant of additional increments to the Nursing Staff has been under consideration of Government. In supersession of Ministry of Finance (Department of Expenditure) O.M.No.F.5(11)/E.III(A)/ or rinance (Department of Expenditure) of the now pleased to 75, dated the 8th May, 1975, the President is now pleased to grant additional increment (not absorbable) to the Nursing Staff working in the Central Govt. Hospitals/Institutions under the Ministry of Health and family Welfers to the extent indicated below:

 - 1) B.Sc. (Hons.) Nursing B.Sc. Nursing/Post Basic/Post Certificate B.Sc. Nursing.
 - II) Post Graduate degree in Mursing i.e. Master in Mursing (M.Sc. Wursing).

This will take offect from

- 3. Only two additional hon-absorbable increments will be admissible to a nurse in a particular grade where possession of such qualification are not required as per Recruitment Rules.
- These increments will be granted subject to the condition that the concerned Nursing Staff are not required to possess Ciploma/Degreu/Post Graduata Dagree in Nursing indicated at paras 1 and 2 above, as a condition of their employment and also that they had not been allowed a higher initial pay on account of their possessing these qualifications prior to or on or after. 1.10.1986.

- The grant of the aforesaid increments is subject to the condition that the concerned Nursing Staff is not required to possess the qualification, for which the increment is claimed, as a condition of employment and that they have not been allowed a higher initial. pay on account of the said qualifications prior to/ on/ or after 01-10-1986.

- These orders were issued in supersession of Ministry of Finance OM NO. F. 5(11)/E.III(A)/75 dated 8th May 1975, and with the concurrence of Department of Personnel and Training vide their Diary No. 617/83-Pay-I dated 07-03-1988 and Ministry of Finance are their Diary No. 1162/E.III/88 dated 21st March 1988.

Subject:- Qualification Pay to the Nursing Staff - Regarding.

The undersigned is directed to say that vide this Ministry's O.M. No. Z.28016/8/1987-PMS, dated 23rd March, 1988, the Nursing Staff working in the Central Government Hospitals/Institution under the Ministry of Health and Family Welfare and other Ministries/Departments were sanctioned additional increments (non absorbable) for attaining additional qualifications to the extent indicated below:

- (a) One increment to the Nursing Staff holding the following Posts Certificate Diploma of 10 months duration or any other 10 months Diploma Course designed and approved by the Indian Nursing Council from time to time:-
 - (i) Diploma in Nursing Education and Nursing Administration;
 - (ii) Diploma in Psychiatric Nursing;
 - (iii) Diploma in Pediatric Nursing;
 - (iv) Diploma in Public Health Nursing;
- (b) Two increments to the Nursing Staff possessing the following qualifications:-
 - (i) B.Sc. (Hons.)/B.SC./Post Basic B.Sc./Post Certificate B.Sc. in Nursing:
 - (ii) Post Graduate Degree in Nursing i.e., M.Sc (Nursing);
- 2. The above benefit is effective from: -
 - (i) 01-10-1986 to those Nursing Staff who were already in service and possessed any of these qualifications;
 - (ii) The date of appointment to those who were recruited after 01-10-1986 an dpossessed these qualifications at the time of appointment; and
 - (iii) The date of publication of results for those in service who acquired the relevant qualification after 01-10-1986.
- 3. Only two additional non-absorbable increments are admissible to a Nurse in a particular grade where possession of such qualifications is not required as per Recruitment Rules.

- 4. The grant of the aforesaid increments is subject to the conditional that the concerned Nursing Staff is not required to possess the qualification, for which the increment is claimed, as a condition of employment and that they have not been allowed a higher initial pay on account of the said qualifications prior to/on/or after 01-10-1985.
- 5. These orders were issued, in super-session of Ministry of Finance O.M. No. F.5(11)/E.III(A)/75, dated 8th May, 1975, and with the concurrence of Department of Personnel and Training vide their Diary No. 617/88-Pay-1, dated 07-03-1988 and Ministry of Finance vide their Diary No. 1162/E.III/88, dated 21st March, 1988.
- 6. The above scheme was reviewed by the Ministry of Health and Family Welfare in consultation with the Department of Personnel and Training in the light of the two OMs No. 1/2/89-Estt (Pay-1), dated 31st January, 1995 and 9th April, 1999 and it was decided to continue the scheme.
- 7. The above scheme has been further reviewed after revision of pay scales of nurses on implementation of 6th Central Pay Commission order. It has been decided to continue the scheme in the present format with the slight change that the increment to be granted will be 3% of the basic pay of the nursing staff concerned.
- 8. This issues with the concurrence of the Integrated Finance Division of Ministry of Health and Family Welfare vide Dy. No. 3816/AS&FA, dated 15-10-2009.
