Sub.:- Participation of Railway Employees appointed against sports quota, in various Championships/Tournaments by representing Non-Railway teams.

Ref.:- RSPB's letter No. RSPB/98/PARTICIPATION dt. 14.12.1998.

Please refer to RSPB's letter dt. 14.12.1998 (copy enclosed) containing guidelines for participation of Railway Employees appointed against sports quota in various Tournaments/Championships by representing Non-Railway teams.

It has been observed that some of the Zonal Railways / Production Units are not following the instructions as contained in RSPB's letter referred above and allowing their sportspersons for representing State teams in the National Championships or in other Tournaments/Championships, where IR Teams are also one of the participants, without obtaining "No Objection Certificate" from RSPB.

All Zonal Railways / Production Units should follow the instructions as contained in RSPB's letter referred above and not allow any sportspersons to represent Non-Railway team in the National Championships or in other Tournaments/Championships, where IR Teams are also one of the participants, without obtaining "No Objection Certificate" from RSPB. Zonal Railways/Production Units may send the names of sportspersons who are not selected to represent Indian Railways and willing to participate in the said championships/tournaments from State team, at least one week before the start of the championship, after the recommendation of the Secretary of concerned Sports Association. Separate permission from RSPB will be required for each championship/ tournament.

If any sportsperson is found to represent state team in Nationals or in any other championship/tournament where IR team is also one of the participant, without obtaining "NOC" from RSPB, he/she will be not allowed to participate in the All India Railway Championships and also no incentives will be granted to him/her from RSPB.

Sub:- <u>Participation of railways sportspersons in various</u> tournaments / championship.

While it is appreciated that some Railway Employees appointed against sports quota, participate in various Tournaments / Championships by representing non-Railway teams, to keep in touch with match practice but there is a need to keep a close watch on the performances of such sportspersons as well as to ensure that Railways interests are no compromised.

- The following instructions are therefore issued for guidance:
  - i) For participation in private tournament / championship, such sportspersons may be permitted with the prior approval of the General Secretary of the Sports Association concerned:
  - ii) In tournaments where the zonal railway team is also one of the participants, such permission may be granted by the General Sectetary of the concerned Railways Sports Association keeping in view the interest of the Railway Team; and
  - In respect of participation of such sportspersons invarious National Championships, Federation Cup. Tournaments etc., where the Indian Railway Team is also one of the participants, approval of RSPB will be necessary. In such cases, recommendation of the Secretary of Sports. Association in be sent in time.
- 3. It is requested that these guidelines may be circulated to concerned for strict compliance.
