Sub: -Out-of-turn promotion and recruitment of Sportspersons in Intermediate grades - Creation of supernumerary posts for.

Ref:- Board's letter of even number dated 30.11.94.

The matter has been reviewed by the Board in the light of the deliberations in the RSCB Executive Committee's meeting held on 18.1.95 and it has been decided to delete para 3 of their letter referred to above.

- 2. It is clarified that the sportspersons may be allowed the benefit of seniority from the date of their cut-of-turn promotion or appointment in the intermediary grade having no element of direct recruitment, against the special supernumerary posts created for the purpose. With a view to ensuring that the interests of the other employees in the cadre are not adversely affected, the Railways may create special supernumerary posts with matching surrender at every stage of subsequent promotion of sportspersons, as indicated in the hypothetical case brought out in the Annexure.

iii) He will be assigned seniority : At this stage a special in grade Rs.1600-2660 from the date of promotion. He can be promoted to the next grade of Office Supdt. (Rs. 2000-3200) either on out of turn basis on sports account or in his own turn on the basis of seniority in grade Rs.1600-2660.

supernumerary post in grade Rs.2000-3200 will be created to accommodate this promotion. In case he came up for promotion in his own turn as per the seniority, the next eligible person will be empanelled/promoted in the slot vacated by him by moving over to special supernumerary post.

The special supernumerary post created earlier in grade Rs. 1600-2660 would vanish. Matching surrender will be required for creation of a special supernumerary post in grade Rs.2000-3200, to the extent of difference between a post in grade Rs.1600-2660 and that in grade Rs.2000-3200.

- Note :- 1. If a sportsperson is appointed or promoted to a grade having an element of direct recruitment, his appointment or promotion will be adjusted against a direct recruitment vacancy. Special supernumerary post need not be created in such a situation.
  - 2. Special supernumerary posts will be personal to the incumbents.

- i) A sportsperson is appointed as Head Clerk in grade Rs.1400-2300, which is an intermediary grade, without any element of direct recruitment.
- : A special supernumerary post will be created in grade Rs.1400-2300 to accommodate this appointment so that the promotion of staff in grade Rs.1200-2040 is not affected.
  - ii) He will be assigned seniority in grade Rs.1400-2300 from the date of recruitment. He can be promoted to the next grade of Chief Clerk (Rs.1600-2660) either on out of turn basis on sports account or in his own turn on the basis of seniority in grade Rs.1400-2300.
- Matching surrender will be required for creation of this special supernumerary post.

: At this stage a special supernumerary post in grade Rs.1600-2560 will be created to accommusdate this promotion. In case he came up for promotion in his own turn as per the semiority the next eligible person will be empanatled/ promoted in the slot vacated by him by moving over to the special supernumerary post. special supernumerary post created earlier in grade Rs.1400-2300 will vanish.

Matching surrender will be required for creation of the special supernumerary post in grade Rs.1600-2660 to the extent of difference between post in grade Rs.1400-2300 and that in Rs.1600-2660.
