**Sub: Treatment of absence of Railway Employees participating in Sports activities as  
on duty.**

1. Reference Ministry of Railways letter No. E(W)72SPI-4 dated 24.01.1981 on the above  
subject.

2. In modification of the instructions contained in item (c) therefore, it has since been decided  
that Railway employees participating in coaching camps for a period not exceeding 30 days prior to  
the National Championships may be treated as on duty, in addition to the period of participation in  
actual events as indicated in (b) of Board's letter dated 24.01.1981 referred to above.

3. It has also been decided that Railway sportsmen/women participating as members of the Railways teams sponsored by RSCB in important sports events which are not termed as 'Nationals' but are of national importance, such tournaments being specified by the Railway sports Control Board in the coaching camps prior to actual participation in such events, will be treated as on duty.

4. List of RSCB approved tournaments to be treated as on duty is enclosed (Annexure 'A').

5. These orders take effect from 01.04.1985.
