**Sub.:- Processing the recruitment cases, forwarded by Railway Board.**



Railway Board forwards the appointment cases of sportspersons to Zonal Railways / Production Units generally with the remarks that take necessary/ appropriate action at your end and advise the final course of action to Board's office; which means that Railway has to complete all formalities for appointment at their end and advise Board whether the Selection Committee has recommended the name of the candidate for appointment or not and if the name of the candidate is recommended for appointment by the Selection Committee, the date of appointment of the sportsperson should be advised to Board's office.

In case where the Trial Report is called for from the Railway/Unit, they have to submit the Trial Report of the candidate to Board, duly signed by the members of the Trial Committee, with clear remarks about the utility of the sportsperson for Zonal Railway and Indian Railway teams, for further action in this office.

In case of any delay in taking final decision on the appointment of a sportsperson, an interim reply mentioning the position of the case should be sent to Board's office.
