Dear Shri

Sub.:- Recruitment of sports persons against Talent Scouting Quota – timeframe for dealing CA(iii) Cases.

It is observed that some of the Zonal Railways / Production Units are not taking prompt action on the CA(iii) and other similar cases forwarded by Railway Board to these units for recruitment of sports persons under Talent Scouting Quota. A number of such cases are lying pending with Railways/Units and some of these are about 2 years old. Due to delay on Railway's part some of the candidates have been rendered ineligible due to either becoming overage or on account of their old sports achievements. In these situations it becomes embarrassing to put up proper reply to the VIPs concerned who have recommended these cases.

It is therefore decided that the Railways/Units should conduct the trial of the candidate, as per the laid down policy guidelines, within 3 months from the date of issue of Board's letter and complete all other recruitment formalities within next three months, in case the candidate is found fit during the trial and is recommended by the Trial Committee for recruitment against Talent Scouting Quota. In case of a candidate not found fit during the trials, reply be sent to Railway Board immediately after the trials with a copy of the trial report. Railways/Units should also endorse a copy of the letter sent to the candidate for trial and also the copy of offer of appointment to the candidate who is found fit, to the Director/Estt.(Sports), Railway Board, for information.

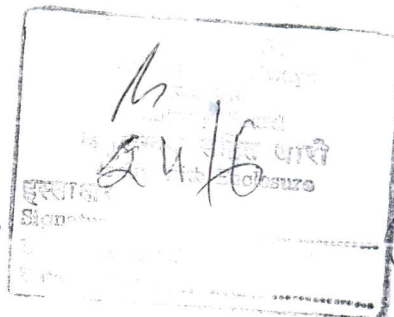
If, Railway/Unit is not able to consider a particular case due to valid reasons, the same be returned to this Board within one month from the date of issue of this office's letter with detailed justification for the same. However, Railways/Units should not return the cases pertaining to individual sports on the ground that they have not a team in that particular sports discipline as in individual events even a single person can participate in the All India Railway and National Championships. Besides, Railways are free to form teams in all of the sports disciplines, recognised by RSPB.

In some cases it has been observed that Railways/Units have returned the cases to Board with the remarks that they have distributed their quota for different sports disciplines. However, at the end of the year it was observed that their Talent Scouting Quota was not fully utilized. This requires to be look into and such lackadaisical approach be avoided. In case the allotted quota of a particular unit is exhausted, Board may be approached for additional quota, if required, after the complete utilization of Talent Scouting Quota allotted to their Railway/Unit.

These instructions issued with the approval of Board(MS) and President/RSPB. You are requested to ensure strict compliance of these instructions.
