ORDER

Further to Railway Board's Order of even number dated 17.11.2023 constituting a Committee for conducting Secret Ballot Elections for verifications/recognitions of Trade Unions on Zonal Railways including Metro Railway, CLW/Chittaranjan and RCF/Kapurthala, Ministry of Railways have decided that the engagement of Shri Rajiv Kishore, Retd. AM/HR and Shri Alok Kumar, Retd. PCPO/SWR, nominated in the Committee as its Chairman and Member, respectively, will be regulated by the following terms and conditions:-

- (i) **Remuneration**:- Remuneration for attending/deliberations in the meetings of the Committee will be paid at the rate of Rs.14000/- per day for Shri Rajiv Kishore, Retd.AM/HR, Chairman of the Committee and Rs.13,000/- per day for Shri Alok Kumar, Retd.PCPO/SWR, Member of the Committee. The Remuneration per month together with pension will be restricted to Rs.2,25,000/- or last pay drawn, which is lower.
- (ii) **Travelling facilities and allowances**:- For journeys in connection with the work of the Committee, both retired officers will be entitled for the Duty Card Pass facilities as per entitlement of the officers of equivalent status on duty. Similarly, the facility of air journey as entitled to the officers of equivalent status on duty shall be available to them. They will be paid TA/DA as admissible to serving officers of equivalent status. They will be their own controlling officers for the purpose.
- (iii) **Road Transport**:- They will be entitled to Transport Facility as admissible to serving officers of equivalent status for undertaking journeys in connection with the work of the Committee. Alternatively, they will be paid conveyance charges as per the extant instructions at par with the officers of equivalent status for actual use of own car for local journeys. They will be entitled to staff car facility while on tour at outside stations.
- (iv) **Rest House facility**:- They will be entitled to Railway Officers Rest House facility while on tour on the same terms and conditions as for serving railway officers of equivalent status.
- (v) **Telephone**:- They will be entitled to CUG facility as per the entitlement of the officer equivalent to post held by them before retirement.
- (vi) **Secretarial Assistance**:- Secretarial Assistance will be provided by Railway Board.
