Sub: Grant of Special Compensatory Allowances subsumed under Tough Location Allowance: Implementation of Seventh Central Pay Commission's recommendations.

Consequent upon the acceptance of the recommendations of the Seventh Central Pay Commission, in supersession of the existing orders for grant of Special Compensatory Allowances viz. Special Compensatory (Remote Locality) Allowance, Special Compensatory (Bad Climate) Allowance, Special Compensatory (Scheduled/Tribal Area) Allowance and Sunderban Allowance which have been subsumed in Tough Location Allowance, the President is pleased to decide the rates of these Special Compensatory Allowances (subsumed in Tough Location Allowance) to Railway employees as under:

2. These rates shall increase by 25 per cent whenever the Dearness Allowance payable on the revised pay structure goes up by 50 per cent.

3. The terms 'Pay Level' in the revised pay structure means the 'Level in the Pay Matrix.'

4. In respect of those employees who opt to continue in their pre-revised pay structure/Pay scales, the corresponding Level in the Pay Matrix of the post occupied on 01.01.2016 as indicated in Railway Services (Revised Pay) Rules, 2016 would determine the allowance under these orders.

5. Sunderban Allowance, categorized as Tough Location Allowance-III, shall be admissible to the Railway employees working in Sunderban areas South of Damper Hodge's line, namely, Bhagatush Khali (Rampura), Kumirmari (Bagna), Jhinga Khali, Sajhakhali, Gosaba, Amlamathi (Bidya), Canning, Kultali, Piyali, Nalgaraha, Raidighi, Bhanchi, Pathar Paratima, Bhagabatpur, Saptamukhi, Namkhana, Sikarpur, Kakdwip, Sagar, Mousini, Kalinagar, Haroa, Hingalganj, Basanti, Kuemari, Kultola, Ghustghata (Kulti) area. The allowance shall be admissible only upto the period for which the Government of West Bengal continues to pay this allowance to its employees.

6. Scheduled/Tribal Area Allowance and Bad Climate Allowance, categorized as Tough Location Allowance-III, shall be admissible only in those States where Scheduled/Tribal Area Allowance and Bad Climate Allowance are admissible and shall be discontinued in those States where it has been discontinued for the State Government employees with effect from the date(s) of such discontinuance.

7. In the event of a place falling in more than one category, the higher rate of Tough Location Allowance will be applicable.


8. Tough Location Allowances shall not be admissible along with Special Duty Allowance. However, employees have the option for continuing Special Compensatory (Remote Locality) Allowance at old rates of 6th CPC, where it was admissible, along with Special Duty Allowance at revised rate of 10% of Basic Pay.

9. Employees may exercise their option to choose either Hard Area Allowance which is admissible along with Island Special Duty Allowance or one of the Special Compensatory Allowance, subsumed under Tough Location Allowance as mentioned in Para 1 above.

10. **These orders shall take effect from 1st July, 2017.**







विषय: कठिन यात्रा भत्ता के अंतर्गत शामिल विशेष प्रतिपूरक भत्ता प्रदान करना - सातवें केन्द्रीय वेतन आयोग की सिफारिशों का क्रियान्वयन।

सातवें केन्द्रीय वेतन आयोग की सिफारिशों को स्वीकार करने के परिणामस्वरूप, विशेष प्रतिपूरक भत्तों अर्थात् विशेष प्रतिपूरक (दूरस्थ स्थान) भत्ता, विशेष प्रतिपूरक (खराब मौसम) भत्ता, विशेष प्रतिपूरक (अनुसूचित/जनजातीय क्षेत्र) भत्ता और सुन्दरघन भत्ता जिन्हें कठिन स्थान भत्ता में शामिल कर दिया गया है, प्रदान करने के मौजूदा आदेशों का अधिक्रमण करते हुए, राष्ट्रपति रेल कर्मचारियों के इन विशेष प्रतिपूरक भत्तों (कठिन स्थान भत्ता में शामिल) की दरें निम्नानुसार सहर्ष निर्धारित करते हैं:

2. जब संशोधित वेतन संरचना में देय महगाई भत्ता बढ़कर 50 प्रतिशत हो जाएगा तो इन दरों में 25 प्रतिशत वृद्धि हो जाएगी।

3. संशोधित वेतन संरचना में 'वेतन लेवल' शब्द का अर्थ है 'वेतन मैट्रिक्स में लेवल'।

4. जो कर्मचारी अपने संशोधनपूर्व वेतन संरचना/वेतनमान में बने रहने का विकल्प देते हैं, उनके संबंध में इन आदेशों के अंतर्गत भत्ते का निर्धारण रेल सेवा (संशोधित वेतन) नियम, 2016 में यथा निर्दिष्ट 01.01.2016 को अधिग्रहित पद के वेतन मैट्रिक्स में तदनुसूची लेवल में किया जाएगा।

5. सुन्दरवन क्षेत्र के साउथ ऑफ डैम्पियर हॉज लाइन जैसेकि भगतुश खली (रामपुरा), कुमिरमरी (बंगना), झिंगा खली, सजनाखली, गोसाबा, अमलामति (बिया), कैनिंग, कुल्टली, पियाली, नलगरहा, रायदिषी, बाधी, पत्थर प्रतिमा, भागबतपुर, सप्तमुखी, नामखना, सिकरपुर, काकवीप, सागर, मौसिनी, कालीनगर, हरोआ, हिंगलगंज, बसति, क्यूमारी, कुल्टोला, घुसिघाटा (कुल्टी) क्षेत्र में कार्य करने वाले रेल कर्मचारियों को कठिन स्थान भत्ता-III के रूप में कोटिबद्ध सुन्दरवन भत्ता देय होगा। यह भत्ता केवल उसी अवधि के दौरान देय होगा जिस अवधि तक पश्चिम बंगाल सरकार अपने कर्मचारियों को यह भत्ता देती रहेगी।

6. कठिन स्थान भत्ता-III के रूप में कोटिबद्ध अनुसूचित/जनजातीय क्षेत्र भत्ता और खराब मौसम भत्ता केवल उन राज्यों में देय होगा जहां अनुसूचित/जनजातीय क्षेत्र भत्ता और खराब मौसम भत्ता देय है और उन राज्यों में उस तारीख से देना बन्द कर दिया जाएगा जिस तारीख से उस राज्य सरकार के कर्मचारियों को देना बन्द कर दिया गया हो।


7. यदि कोई स्थान एक से अधिक कोटि में आता हो तो कठिन स्थान भत्ता का उच्चतर दर लागू होगा।

8. कठिन स्थान भत्ता विशेष इयूटी भत्ता सहित देय नहीं होगा। बहरहाल, कर्मचारियों के पास मूल वेतन के 10% संशोधित दर पर विशेष इयूटी भत्ता के साथ-साथ छठे केन्द्रीय वेतन आयोग की पुरानी दरों पर विशेष प्रतिपूरक (दूरस्थ स्थान) भत्ता प्राप्त करते रहने का विकल्प होगा।

9. कर्मचारी या तो कठिन क्षेत्र भत्ता जो द्वीपीय विशेष इयूटी भत्ता के साथ देय है या ऊपर पैरा 1 में यथा उल्लिखित कठिन स्थान भत्ता के अंतर्गत सम्मिलित किसी एक विशेष प्रतिपूरक भत्ता को चुनने का विकल्प दे सकते हैं।
