SAFETY (ACCIDENTS & RULES)

1. Train accidents (consequential and indicative) **excluding** cases of train wrecking, trespassing and run over, persons falling out of running trains, casualties in roof-top travelling, cases of landslides, breaches, OHE breakdowns, public agitations, etc.
2. Monitoring of consequential train accidents.
3. Receipt and circulation of consequential and indicative train accident messages.
4. Compilation & updating of Accident related data and statistics.
5. Analysis of consequential train accident statistics and trends.
6. Maintenance of Monthly Statement 'A' & 'B' showing detailed statistics of train accidents on Indian Railways.
7. Preparation of safety briefs for visits of Ministers, Board, Parliamentary Standing Committee and other similar Committees.
8. Submission of Monthly Review of train accidents to Board.
9. Para on Safety for Monthly Summary for the Cabinet.
10. Compilation of the Annual Safety Performance Booklet of Indian Railways.
11. Chapters on 'Safety' for 'Indian Railways 'Annual Report & Accounts' and Indian Railways 'Year Book'.
12. Establishment matters relating to staff in Safety Control.
13. Parliamentary business related to above items, including Calling Attention Notices, Cut Motions, Suo Moto Statements and Motions on Demands of Grants, etc. relating to Train Accidents and Safety.
14. Recommendations of Commissioners of Railway Safety relating to Rules.
15. Issues related to replacement of Guard's Boxes.
16. RTI cases related to above items.
17. Review of Safety Scenario with Zonal Railways (NER, ECR, NFR, WCR) and their Divisions especially in respect of systemic shortcomings/deficiencies, their identification and remedial measures thereon; and safety related Inspections of at least two installations in different Divisions in a month.
18. Any other work assigned by senior officers.

SAFETY (IMPLEMENTATION)

1. Monitoring of Implementation of recommendations of High Powered Railway Accident Committees and Railway Safety Review Committee, HLSRC, etc.
2. Inspection Notes of Board Members, other Safety Officers – follow up.
3. Inspections and spot checks on actual practices being followed on Railways in the observance of rules and regulations affecting safe operation of trains.
4. Safety Inspections and Safety Drives.
5. Analysis of SPAD Cases and their follow up including DAR.
6. Accident Free Service Award to select Safety category staff; Zonal Safety and other Awards; Policy to reward persons who help in averting train accidents.
7. Issues regarding training of Safety Category Staff including PME, Refresher, Safety Camps etc.
8. Issues related to Psycho-testing of Safety related staff, coordination with RDSO's Psycho-Technical Cell on Safety related matters, Assessment Centres.
9. Coordination of activities of Safety Organisation on Zonal Railways, including Safety set up and preparation of safety briefs for various meetings, such as Board Meetings, Minister's Meeting with Board, PREM meetings, Consultative Committee of Members of Parliament, General Manager's conference, COM's Conference, CSOs' Conference, etc.
10. Enhancing and strengthening communication with field units regarding safety instructions; Activities relating to enhancement of safety in train operation.
11. Follow up action on corporate documents e.g. 'White Paper on Safety on IR', 'Corporate Safety Plan', etc.
12. Follow-up action on decisions taken in various meetings/conferences/committees and studies on items pertaining to Safety (Imp.).
13. Issues related to provision of Hand Signal Lamp and Tail Lamp etc.
14. Parliamentary business related to above items.
15. RTI cases related to above items.
16. Matters related to Loco Pilot Simulators, CVVRS, etc.
17. Review of Safety Scenario with Zonal Railways (ER, SER, ECoR and Metro/Kolkata) and their Divisions especially in respect of systemic shortcomings/deficiencies, their identification and remedial measures thereon; and safety related Inspections of at least two installations in different Divisions in a month.
18. Any other work assigned by senior officers.
