Sub:-Allocation of work to the Ministers of State in the Ministry of Railways

The Minister of Railways has allocated the following work to Ministers of State for Railways Shri Danve Raosaheb Dadarao- MOSR(D) and Smt Darshana Vikram Jardosh-MOSR(J):

I. Cases to be put up to the Minister of Railways through MOSR(D):

- a) Replies to Starred & Unstarred Parliament Question;
- b) Calling Attention Motion;
- c) Cases of Directorates/Departments under Member/Infra, Member/T&RS, DG/RHS & DG/Safety which are beyond the powers of Board Members/DGs;
- d) CCEA/Cabinet Notes in respect of para (c) above.

II. Matters to be disposed of at the level of MOSR(D):

- a) DAR cases of Group B, C & erstwhile Group 'D' Categories of staff where the President is the Disciplinary/Appellate/Reviewing authority;
- b) Matters relating to Official Language;
- c) Monitoring of Railway development works in the following States/UTs:-Andhra Pradesh, Arunachal Pradesh, Assam, Goa, Karnataka, Kerala, Maharashtra, Manipur, Meghalaya, Mizoram, Nagaland, Puducherry, Sikkim, Tamil Nadu, Telangana and Tripura;
- d) Review of PSUs/PUs: DFCCIL, RVNL, IRCON, KRCL, MRVC, BLW, DLMW, IRSDC & CLW;
- e) All Parliamentary matters related to Assurances, laying of Reports/Regulations/Rules, Authentication of Papers, Replies to Hon'ble MPs under Rule 377 etc.



Π Cases to be put up to the Minister of Railways through MOSR(J):

- Cases of Directorates/Departments under Member/O&BD, Member/Finance, DG/HR and DG/RPF which are beyond the powers of Board Members/DGs;
- CCEA/Cabinet Notes on above; b)
- c) Matters related to Wi-fi and High Speed Rail (HSR).

IV. Matters to be disposed of at the level of MOSR(J):

(a) Monitoring of Railway development works in the following states/UTs:-Bihar, Chhattisgarh, Chandigarh, Delhi, Gujarat, Haryana, Himachal Pradesh, Jharkhand, Jammu & Kashmir, Ladakh, Madhya Pradesh, Odisha, Punjab, Rajasthan, Uttar Pradesh, Uttarakhand and West Bengal;

(b) Review of PSUs/PUs:- RAILTEL, CONCOR, IRCTC, RITES, NHSRCL, IRFC, ICF, RCF and RWF;

(c) Staff Welfare and Labour Legislations;

(d) Matter relating to Public Grievances & Staff Grievances (other than DAR);

(e) All Parliamentary matter in the absence of MOSR(D).

Cases to be submitted directly to the Minister of Railways: 2.

(a) VIP References addressed to the Minister of Railways;

- (b) Approval for posting of officers in SAG and above in Railway Board and posting orders beyond powers of Railway Board;
- (c) Approval of postings of officers as DRM and AGM;

(d) All proposals requiring ACC approval;

- (e) Approval of panels for promotion to JAG & above posts;
- (f) Any other cases & urgent/immediate matter.
- It may be ensured that all files are submitted/routed to the Ministers strictly in accordance 3. with this allocation of work.
