4. Concerned PCSCs are requested to revert Inspectors into Sub-Inspector first and then spare them.
5. The concerned staff should be relieved immediately. Since these transfers are on request, the terms and condition applicable to request transfer will apply.
6. Before relieving, it may be ensured that RPF/RPSF personnel are clear from DAR/Vigilance/Criminal Case angle.
7. Inter Railway transfer has not been considered due to lack of vacancies in desired zone in respective category. Hence, a waiting list will be issued in due course.
