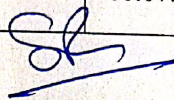

Sub:- Inter Railway transfer of RPF personnel on completion of tenure, child care giver, Ex-Servicemen & Working couple ground.

Apropos above, waiting list of 214 RPF personnel was circulated vide Board's letter No. 2023/Dir/RPF/Committee /Misc, dated- 12.07.2023. Transfer order of 20 RPF personnel out of these 214 has been issued vide Board's letter dated- 13.12.2023. 1 RPF personnel (*Satyvati Verma, LCT/NCR*) out of remaining 194 RPF personnel has been transferred on mutual exchange basis vide Board's letter dated- 25.01.2024. 1. All RPF personnel mentioned above have given willingness to go on bottom seniority as per RPF Rule 99.2 of RPF Rules, 1987 i.e. to the rank of CT and SI.
2. The seniority of above mentioned RPF personnel will be regulated in terms of Rule 99.2 of RPF Rule-1987.
3. Concerned PCSCs are requested to revert ASI, HC into CT first and IPF into SI and then spare them. Name mentioned at S.No. 4 may be reverted to SI and spare him and staff mentioned at S. No. 6,7, 13, 22, 51, 52, 53, 68, 69, 71 may be reverted into CT and then spare them.
4. The concerned staff should be relieved immediately. Since these transfer are on own request, the terms and conditions applicable to request transfer will apply.
5. Before relieving, it may be ensured that RPF personnel are clear from DAR/Vigilance/Criminal Case angle.
6. The order of Inter Railway transfer has been issued as per vacancy and data provided by the concerned zones.
7. Zonal Railways are requested to apprise Board's office immediately in case any anomaly is found in the above list before relieving the RPF personnel on transfer.
8. Few staff have been given 2nd and 3rd choice due to vacancy position.
9. A new Waiting list of remaining staff will be issued in due course.
