STANDING ORDER NO.48

DEPUTATION OF MEMBERS OF THE FORCE TO OTHER ORGANISATIONS.

Instances have come to my notice wherein members of the Force had directly persued their cases of deputation to other organisations outside the Railways. Such a conduct on the part of the members of the Force is certainly not desirable.

With immediate effect the following guidelines governing deputation of the RPF personnel are hereby laiddown for strict compliance:

- 1. No member of the Force shall directly approach any other organisation outside the Railway department for deputation.
- 2. With the prior approval of Chief Security Commissioner, members of the Force may be allowed to proceed on deputation in public interest to other departments of the Railways on such terms and conditions as may be offered by the borrowing department.
- 3. Deputation to organisations/departments other than the Ministry of Railways shall be with the express approval of DG/RPF which would be on such terms and conditions as may be offered by the borrowing department.

4. CRITERIA FOR DEPUTATION

While recommending the case for deputation following criteria will be observed:

- i) To provide exposure to related field work
- For upgrading the additional skills and knowledge useful for the working of RPF
- iii) To effect improvement in promotional prospects of officers stagnating at a particular level

5. PARAMETERS FOR DEPUTATION

- No member of the Force who has not completed five years of active Appointment after initial service will be considered for any deputation
- Promotee officers SI/IPF must have put in minimum of 10 years of Scrvice
- All other ranks who have put in in aggregate of 10 years of service iii)

PERIOD OF DEPUTATION

Maximum period of deputation will be as under:

- Constable to ASI-3 years extendable by

SI/IPF- 3 years one year

- 7. All indents for RPF from the borrowing organisations(outside Railways) will be circulated by DG's Dte to all the CSCs seeking for willingness of RPF staff desirous of going on deputation.
- 8. CSCs will also ensure that cases of no such candidates is recommended who is undergoing any punishment or is facing vigilance enquiry or whose work and conduct is not satisfactory.
- 9. CSCs while recommending the case will furnish a complete biodata of the officer/staff as per attached proforma(Annexure A).
- 10. Officer/staff shall only be spared on deputation after getting formal approval of DG/RPF.
