Sub:- Transfer of the members of the force.

Ref:- Board's letter No. 2014/Sec(Spl)/6/12, dated 13.03.2023 (Directive-58) & 29.03.2023 (Directive-60).

In partial modification of Directive-58 & Directive-60 regarding transfer of member of the force, the following guidelines are being issued:-


1. The sub para I(a)(iv) of para D of the directive-58 may be read as under:-

Existing provision	Modified provision
In any of the cases above, a member of the Force shall be adjusted only against the vacancies available in their respective categories like- <u>General, OBC</u> , SC or ST etc. Any transfer against a vacancy available 'out of the applicant's category', shall not be permitted.	In any of the cases above, a member of the Force shall be adjusted only against the vacancies available in their respective categories like- <u>General/OBC</u> , SC or ST etc. Any transfer against a vacancy available 'out of the applicant's category', shall not be permitted.

2. The sub para I(b) of para D of the directive-58 may be read as under:-

Existing provision	Modified provision
Notwithstanding to para- a(i) above, transfers shall be allowed on 'Mutual exchange basis' within the same reservation & recruitment categories, provided both of the members of the force have given a consent, written or digitally, to accept the new seniority as envisaged under Rule-99.2, of the RPF Rules 1987.	<u>All enrolled member of the force shall be eligible for Inter Zonal transfer on mutual exchange basis after completion of "Probation Period" within the categories (i.e., UR/OBC to UR/OBC, SC to SC & ST to ST)</u> provided both of the members of the force have given a consent, written or digitally, to accept the new seniority as envisaged under Rule-99.2, of the RPF Rules 1987.
